**Consideration of a Post-Incident Course of Training for Captain Scott Anacker.** <u>Motion</u>: Hannigan/Hulsizer – empower Chairman Dudley, on behalf of the Board, to approve the Trainee Evaluation Committee's course of training for Captain Anacker if developed by October 21 – Carried.
