Whirlpool Donates to Amana Elementary School Lunches

Amana Elementary School Principal, Ben Macumber had a nice surprise last week when he was contacted by Misti Huedepohl and Jennifer Wanliss of Whirlpool Amana to tell him that Whirlpool would be making a donation of \$3,000 to the Amana Elementary hot lunch program.

As Macumber said in an email last week, Whirlpool's donation will be used to help those families that sometimes are unable to cover their hot lunch and snack fees at school. "Our plan is to use the funds for families who are not identified as part of the Free / Reduced Lunch pricing but could benefit from having their delinquent lunch (fees) subsidized . . . I do anticipate this money lasting well past this year which is very exciting."

"Words cannot express the gratitude I have for the amazing folks at Amana Whirlpool. . . what they have been able to provide Amana Elementary families in the way of gifts, food and clothing has been a miracle," Macumber told us. Adding that he was especially grateful for the work of longtime school volunteer and supporter, Jamie Bormann.

The Whirlpool representatives stopped by Amana Elementary School September 7 to present Macumber with a check for \$3,000.

South Amana Summer of Music Receives Grant

The Iowa Theatre Artists Company (ITAC) of the Amana Colonies was recently awarded a grant of \$750 from the Community Foundation of Northeast Iowa in support of the South Amana Summer of Music project.

Meg Merckens of ITAC has organized these Friday night musical performances at the Great South Amana Swap meet, an entertaining addition to our summer that has drawn praise from local residents and visitors alike who have greatly enjoyed the blue grass and "Id time" musical performances on the small stage in the South Amana post office parking lot.

Awarded through the Iowa County Community Foundation, the grant is responsible for underwriting the appearance of five Iowa musical groups that include: The Great Bluegrass Herons, The Riverbottom Ramblers, Castle Ridge, Straightback Chair and Bob & Kristie Black and Banjoy.

Since the very first market on May 4, this first-time event in South Amana has welcomed a wide range of patrons from Iowa County, surrounding counties, neighboring states and even visitors from as far north as Canada. BALLOTS NOW SET FOR NOVEMBER IOWA COUNTY RACES

A three-way race to fill the Iowa County Board of Supervisors' seat of the late Neal Huedepohl will highlight the local races in the 2018 general election.

His widow, Teresa Huedepohl, of Marengo, is one of the three candidates vying to fill the vacancy, created when Neal passed away Aug. 7, at his home. He was in the middle of his first term as supervisor, having been elected in 2016.

Also running for the seat, a two-year term, are Bruce Adams, a Republican from Williamsburg, and Dale Walter, a Democrat from Williamsburg. Walter served on the Board of Supervisors from 2009-2017, and was appointed by the Supervisors to fill the vacated seat until a duly elected member is sworn in.

All three filed for the seat by the Aug. 29 filing deadline for candidates to be nominated either by petition or at a county convention called by their political party.

Meanwhile, the stage was set earlier this summer for a four-way race for three four-year seats on the board. Dennis Mathahs, an attorney from Marengo, was the lone candidate nominated at a Democratic convention in Williamsburg. He will be running against Republican incumbents John Gahring, Vicki Pope and Kevin Heitshusen, all whom won the GOP primary.

VETERANS' ECKE**Survivors Pension**

The Survivors Pension benefit, which may also be referred to as Death Pension, is a tax-free monetary benefit payable to a low-income, un-remarried surviving spouse and/or unmarried child(ren) of a deceased Veteran with wartime service.

Eligibility

The deceased Veteran must have met the following service requirements:

- For service on or before September 7, 1980, the Veteran must have served at least 90 days of active military service, with at least one day during a war time period.
- If he or she entered active duty after September 7, 1980, generally he or she must have served at least 24 months or the full period for which called or ordered to active duty with at least one day during a war time period.
- Was discharged from service under other than dishonorable conditions.

Survivors Pension is also based on your yearly family income, which must be less than the amount set by Congress to qualify. (see website below)

While an un-remarried spouse is eligible at any age, a child of a deceased wartime Veteran must be:

- Under 18, OR
- Under age 23 if attending a VA-approved school, OR
- Permanently incapable of self-support due to a disability before age 18

Your yearly family income must be less than the amount set by Congress to qualify for the Survivors Pension benefit. Learn more about income and net worth limitation, and see an example of how VA calculates the Survivors Pension benefit.

How to Apply

To apply for Survivors Pension, download and complete VA Form 21P-534EZ, "Application for DIC, Death Pension, and/or Accrued Benefits" and mail it to the Pension Management Center (PMC) that serves your state. You may also visit your local regional benefit office and turn in your application for processing. You can locate your local regional benefit office using the VA Facility Locator. Jennifer Olson, Director, Iowa Co. Veteran Affairs can help with this process, call her at 319-642-3925 to make an appointment. Jennifer's office is located in the basement of the Court House.
