THE PROGRAM PROVIDES A VARIETY OF SERVICES SUCH AS CASE MANAGEMENT, EMERGENCY RENTAL AND UTILITY ASSISTANCE, DISTRIBUTION OF FOOD AND CLOTHING, TRANSPORTATION, FINANCIAL EDUCATION, REFERRALS AND OTHER SERVICES THAT PROMOTE SELF-SUFFICIENCY AND ECONOMIC STABILIZATION. THE PROGRAM IS BASED OUT OF TWO OFFICES LOCATED IN LAKE WORTH AND BELLE GLADE, AND SERVICES ARE PROVIDED BY CASE MANAGERS THAT ARE FAMILIAR TO THE CULTURE AND NEEDS OF THIS POPULATION. ALL CASE MANAGERS ARE ENGLISH-SPANISH OR ENGLISH CREOLE SPEAKERS.
