**EQUESTRIAN ACTIVITY RELEASE AND INDEMNITY FORM**

In consideration of Folly Farm Show Stables, LLC ("Folly Farm"), granting me permission to ride, handle, show horses and/or otherwise participate in equestrian activities, I hereby assume any and all risk of loss or injury to me and/or my property, whether anticipated or unanticipated, arising from my entry onto the premises located at 75-77 Hartford Rd, Simsbury, CT (the "Premises") and/or my participation in equestrian activities.

I further agree to indemnify Folly Farm and Folly Farm, Inc. (the company which leases the Premises to Folly Farm Show Stables), and their officers, members, board of directors, managers, owners, agents, servants and employees, and hold them harmless from any and all claims, demands, actions, expenses, or liabilities (including attorney's fees and court costs) for any injury or damage to me and/or my property arising out of my entry onto the Premises, and/or participation in such equestrian activities at the Premises and/or arising out of any act or acts of anyone or any animal within my control.

I acknowledge that equestrian activity, such as horseback riding, polo, horse care and maintenance, contain inherent risks of injury and damage to me personally and to my property. Based upon such knowledge, and in consideration of Folly Farm allowing me to enter onto the Premises, I hereby, for myself, my heirs, executors and administrators, waive, release and hold harmless Folly Farm and Folly Farm Inc., their officers members, board of directors, managers, owners, agents, servants and employees, from any and all right, claim, or liability for damages or injuries which might be sustained by me or from any and all right, claim, or liability for damages or injuries which might be sustained by me from any and all claims of any kind or nature that I might have as a result of, or arising

out of, my participation, whether caused by my own act or acts of anyone or any animal within my control.

I authorize Folly Farm to seek emergency medical attention for me as may be required in the event the need arises. **I UNDERSTAND THAT THIS IS A LEGAL DOCUMENT. **Facility Rules**

1. NO smoking or alcohol on the premises.
2. NO candles/flames/fires/pyrotechnics of any kind permitted on the premises.
3. Barn Hours are: Tuesday - Friday 8AM-8PM & Saturday and Sunday 8AM- 5PM.  
The barn is CLOSED to boarders on Mondays. Riders must be out of rings and arenas 30 minutes before barn closing time.
4. All riders or persons handling a horse must sign a release before riding and/or handling any horses in any way. Boarders are responsible for having guests sign releases if they handle your horse in any way. Releases are available in the riding school grooming area and in the Stable office.
5. The speed limit on the property is 5-10 MPH for the safety of animals, riders and children. Parking in designated areas only.
6. Children 14 and under must be supervised by an adult at all times.
7. Appropriate footwear must be worn around horses at all times—no sandals, no open toed shoes.
8. No running, loud voices, or loud music in the barns or near the horses.
9. Please do not give treats to horses other than your own, unless approved by the owner.
10. No verbal or physical abuse of animals is permitted and should be immediately reported to a staff member if witnessed.
11. Please do not leave your horse unattended in any area.
12. Please use the Arena Viewing Rooms to watch riders and refrain from congregating near arena entryways and exit areas.
13. Clean up after your horse and yourself. There are trash and recycling containers, shovels, brooms and muck buckets available throughout the grounds. Please clean up any mess before going to ride.
14. Horses will be turned out in specific turnout areas only – as per management.
15. No horses are to be turned out or free lunged by owners in the rings or arenas without express permission.
16. Please respect the privacy of the people and families who live on the farm. Do not enter their private housing and surrounding areas. Please do not walk or drive across the bridge by the pond. No swimming or fishing in the pond.
17. Please do not enter the feed rooms and the hay and shaving storage areas.
18. Medications or supplements supplied by the owner should be given to your instructor, the barn manager, or the stable owner.
19. NO dogs or pets on the property. (They may remain in the car, at all times, with a window open).
20. Management reserves the right to close Facilities due to inclement weather.

**Riding Rules**

1. Only the owner of the horse or an authorized staff member may ride that horse. If the owner wishes to have another person(s) ride their horse, please notify the FF office in writing. Please give us a note naming all additional authorized riders and please also make sure that these riders have filled out releases.
2. Minors need a note from parent/guardian granting permission to ride any private horse housed at FF other than their own.
3. Buckled ASTM-SEI helmets must be worn at all times when mounted.
4. No jumping without trainer supervision.
5. Riders must pass left shoulder to left shoulder. Please use common sense when approaching young or more inexperienced riders.
6. Faster gaits should be given the rail. Especially if you are walking your horse, please move off of the rail and towards the center of the ring.
7. Please give instructors at least 10 feet of room in the center of the ring.
8. Jumping lessons have the right of way.
9. Lunging during lessons is allowed only with the permission of the instructor.
10. Neat, conservative attire must be worn when mounted. Boots or paddock boots should be clean and polished. Hair should be tied back if applicable.
11. A clean horse, clean tack, pads and girths are expected at all times.
12. Please ALWAYS loudly call out "DOOR!" and WAIT at least five seconds or until you hear a response before opening any closed arena door.
13. Riders may not ride over the bridge by the pond unless they are accompanied by an instructor. Do not ride through the parking lot.
14. During the winter months, the large arena is closed for riding at 3PM on Mondays, 5:30 PM on Wednesdays, and 3PM on Sundays to allow for polo practice. The small arena remains open until 30 minutes prior to barn closing.
15. 24 hours-notice is required to cancel or reschedule a lesson without penalty. If sufficient notice is not given, riders will be charged the normal lesson price.
