### **Clinical Evaluations:**

Anyone convicted of two or more alcohol or drug offenses in five years will be required by the D.D.S. to complete an alcohol and drug abuse evaluation (sometimes called a clinical referral); which can only be done by a state approved clinical evaluator. We will provide you with a list of approved evaluators and can make arrangements for your evaluation at the location of your choice, including all of our offices. These are done by appointment only.

#### Level I Treatment:

Multiple offenders may be required to complete an addiction treatment program. We provide Level I (outpatient) treatment at each of our offices.

### **Defensive Driving Course:**

Traffic offenses that do <u>not</u> involve alcohol or dr including reduction of points will require a Defen Driving certificate. Please contact our office fo schedule if you need this course.
