WHEREAS, to secure the payment of the Assessments, the Declaration established a lien on behalf of and for the benefit of VILLAGE WOOD TOWNHOMES ASSOCIATION, INC. which lien is enforceable through the power of sale granted to VILLAGE WOOD TOWNHOMES ASSOCIATION, INC., pursuant to the Declaration, subject only to any superior liens provided for in the Declaration or at law; and

WHEREAS, from time to time, owners of properties that are covered by the Declaration and are under the jurisdiction of VILLAGE WOOD TOWNHOMES ASSOCIATION, INC. fail to timely pay the Assessments and are in default of their obligation to do so; and

WHEREAS, VILLAGE WOOD TOWNHOMES ASSOCIATION, INC. desires to appoint an Agent and Trustee to act in its behalf to enforce the lien and the Association's power of sale pursuant to the Declaration.

NOW, THEREFORE, VILLAGE WOOD TOWNHOMES ASSOCIATION, INC., as Beneficiary, does hereby (1) revoke any Appointment of Agent and/or Trustee previously made and does MAKE, CONSTITUTE, and APPOINT RICK S. BUTLER, ERIC TONSUL, CLIFF DAVIS, SIPRA BOYD, BRADY ORTEGO, KARREN A. MAXWELL, MELISSA MCLAIN, ADAM ROBERTSON, SANDY HUYNH, CLINT BROWN and/or MIMI BUTLER, of Harris County, Texas, Agents and Trustees, to act on its behalf as directed in enforcing its lien against any lot within VILLAGE WOOD TOWNHOMES ASSOCIATION, INC. that is covered by the Declaration that falls delinquent in the payment of the Assessments; (2) grant unto RICK S. BUTLER, ERIC TONSUL, CLIFF DAVIS, SIPRA BOYD, BRADY ORTEGO, KARREN A. MAXWELL, MELISSA MCLAIN, ADAM ROBERTSON, SANDY HUYNH, CLINT BROWN and/or MIMI BUTLER the power of sale against each such lot in accordance with the law, including, but not limited to, posting or causing to be posted the required notices prior to conducting a non-judicial foreclosure sale; (3) agree to indemnify RICK S. BUTLER, ERIC TONSUL, CLIFF DAVIS, SIPRA BOYD, BRADY ORTEGO, KARREN A. MAXWELL, MELISSA MCLAIN, ADAM ROBERTSON, SANDY HUYNH, CLINT BROWN and/or MIMI BUTLER for any and all losses or causes of action which may arise out of the performance of their duties hereunder (including but not limited to attorney's fees, expenses of litigation, and court costs), provided that no judgment has been entered against RICK S. BUTLER, ERIC TONSUL, CLIFF DAVIS, SIPRA BOYD, BRADY ORTEGO, KARREN A. MAXWELL, MELISSA MCLAIN, ADAM ROBERTSON, SANDY HUYNH, CLINT BROWN and/or MIMI BUTLER finding that their actions complained of were willful, wanton, or reckless, or the result of gross negligence; and (4) ratify any actions taken by RICK S. BUTLER, ERIC TONSUL, CLIFF DAVIS, SIPRA BOYD, BRADY ORTEGO, KARREN A. MAXWELL, MELISSA MCLAIN, ADAM ROBERTSON, SANDY HUYNH, CLINT BROWN and/or MIMI BUTLER, as
