## AMANA NEWS AND NOTES

### Amana is at the Iowa State Fair

The Amana Colonies are once again represented at the Iowa State Fair with the Amana Colonies Convention and Visitors Bureau at booth 311, Aisle 3 at the Varied Industries Building on the fairgrounds in Des Moines.

"It's been huge to see so many people and to hear from them. Some tell us they remember coming to the Amanas when they were kids and some have never heard of us. . . We've had lots of people express a real interest and we are making so many contacts and meeting so many people," said Dana Jensen, events and social media manager, Amana Colonies Festivals. "We're reaching a lot of people."

She or the new Amana Colonies Convention and Visitors Bureau executive director, Stacey Colledge will be at the Amana Colonies booth every day during the fair's run, but volunteers are helping out too. On Monday when we spoke with Jensen, volunteers from the Amana General Store were there at the booth.

Over the weekend the team from Ackerman Winery, Amana, hosted a "how to make a wine cocktail" workshop at the Maytag Kitchen at the Iowa State Fair with over 75 people attending the workshop. "It was the most popular class they've had at the kitchen," said Jensen. Volunteers from Die Heimat, Hotel Millwright and other colony merchants will be spending a half-day or full day in the booth during the fair's run. Several other communities have booths in the Varied Industries Building including Pella and Kalona.

Over 1 million visitors go to the Iowa State Fair each year, making it Iowa's largest event. During the first three days it was open this year, the fair had 82,862 people on Thursday, 103,556 on Saturday and 113,012 on Sunday. This is on track with last year's fair attendance.

### Oktoberfest 2022 Changing it Up

This year's Amana Oktoberfest has some changes in the offering.

In March fan favorite Johnny Wagner, a mainstay at so many Amana Oktoberfests, announced that sadly, he has been forced to retire as his wife's health has taken a turn. The ACCVB is creating a "thank you" basket for the Wagner family in recognition of his and the band's contributions to our autumn festival. They hope to give it to him soon. If you would like to donate an item for the basket please drop it off at the ACCVB office in Amana by September 1.

Having to hustle to fill the Wagner's bands scheduled performances at Oktoberfest 2022 and finding that all the traditional German show bands were long booked for autumn festivals, Amana Colonies Festivals has had to pivot a bit.

Fortunately they have booked a great, new Nashville band, Eli Elger and the Faster Horses. Elger and his band are performing currently at the Iowa State Fair, Jr's Pork Ranch stage. They are known for their two-stepping tunes and party-edown country and western roots. They've promised to learn a couple of polka tunes too. They will be performing on Saturday night at 9 p.m.

Ken and Mary Turbo Accordions Express of Ohio will be here on Friday and Saturday. This will be the first time at our festival, but this highly acclaimed accordion duo will fit right in with our German vibe. The pair have played at Oktoberfests all over the world and have been featured at the German Pavilion at Disney's Epcot Center and at the Alstadt Fest in Goslar/Harz, Germany, plus many events in the Ohio - Illinois region.

There's more. This year's Ceremonial Keg Parade will begin at the Amana Heritage Museum as the festival looks forward to its 60th anniversary. Next year the Amana Heritage Society will be looking at the festival's legacy in Amana with a special Oktoberfest exhibit so this is a nice start to that year of recognition. The move also gives the festival an opportunity to proceed from the west entrance of Amana and down Amana's main street to the Festhalle. The keg will leave the museum about 1:45 p.m. on Friday, Sept. 30 and the keg tapping will take place afterward at the Festhalle with Burgermeister Pat Kellenberger and the festival hosts in attendance.

**MY AMANA EXPERIENCE**

This week, I took a field trip over to The Hotel Millwright restaurant to meet the new chef. His name is Oscar Jackson III, and he hails from Albany, Georgia. Although he's worked in too many cities to name them all, here are a few – Atlanta, GA; Miami, FL; Orlando, FL; Hilton Head, NC; Savannah, GA; and now Amana, IA.

Chef Jackson started working in the restaurant business at age 14 as a dishwasher and busboy at The Waffle House, and learned from everything he could from the kitchen staff. As a teen, he loved to watch Julia Child's and Justin Wilson's cooking shows on PBS, and still counts them among his gastronomic influences today.

When Chef Jackson had learned as much as he could from his co-workers at The Waffle House, he turned his eye toward climbing the culinary ladder. From 2003-2005, he attended The Art Institute of Atlanta, graduating from their Culinary Arts/Chef Training program. At age 26, Chef Jackson became The Chef at the 12 Hotel Exchange in Atlanta. Other notable restaurants on Chef's resume are Four Seasons Atlanta, Johnny Carino's, and Alligator Soul.

Much like his warm personality, Chef Jackson's approach to cooking is to satisfy both the body and the soul. He likes to use classic ingredients like pork chops or short ribs, and add a special touch or an unexpected (but never unwelcome) flavor to enhance the dish. His aim is to give you all the comfort food with a little dash of inspiration. When I asked what dish or meal is his current favorite to cook, he said it is braised short ribs with a cherry reduction, mashed potatoes, and greens. He told me, "You will never leave hungry." I believe him.

I seem to remember I have an anniversary coming up. I bet I know where I'll spend it.


**OBITUARY**

**NEWS RELEASE: ACLUD ELECTION**

The annual election for the Amana Colonies Land Use District (ACLUD) trustees will be held Tuesday, October 4, 2022.

Nomination papers are available by appointment only at the ACLUD office at 4304 220th Trail, in Amana. Papers are also available at the Auditor's Office in the East Courthouse Annex at 970 Court Avenue in Marengo between 8:00 AM and 4:30 PM, Monday through Friday.

The deadline for filing nomination papers is September 9th at 4:30 PM in the Auditor's Office.

Please note the polling hours for this election will be from 12:00 Noon until 8:00 PM at the Middle Amana Fire Station.

Voter registration deadline is Friday, September 19th for this election. Pre-registered voters are required to provide an approved form of identification at the polling place before receiving and casting a regular ballot. Voters who are not pre-registered – such as voters registering to vote on election day – and voters changing precincts must also provide proof of residence. A voter who is unable to provide an approved form of identification (or prove residence if required) 1) may have the voter's identity/residence attested to by another registered voter in the precinct, 2) prove identity and residence using Election Day Registration documents, or 3) cast a provisional ballot and provide proof of identity/residence at the county auditor's office by Noon on Thursday October 6th. Election Day Registrant attestors must provide an approved form of identification. For additional information about providing proof of identity and/or residence visit: <https://sos.iowa.gov/voterid> or phone (319) 642-3923 option # 0. Voters are still encouraged to register by September 19th in the auditor's office if your residence has changed.

Anyone wishing to vote absentee before election day may do so by stopping in the Auditor's Office Monday thru Friday 8:00 AM until 4:30 PM starting September 14th, 2022. Voter Registration Forms and Absentee Ballot Request Forms are also available by mail or on the Iowa County website at [www.co.iowa.ia.us](http://www.co.iowa.ia.us).
