

## HUNTINGTON TOWNSHIP TRUSTEES 45955 STATE ROUTE 162 WELLINGTON OHIO 44090

### Minutes of September 6, 2022

The Huntington Township Trustees met in a regular scheduled meeting at 7:00 PM with the pledge of Allegiance. Attendees: Walter Rollin, Robert Holmes, Sheila Lanning, Matt Combs, Alaina Combs, Abel Combs, Tyler Honoshofsky, Carl Strekely, Dimitri Szynal and Connie Dombrowski. *Motion* by Holmes with a second by Lamb to approve the minutes of August 15, 2022 as written. Roll call: three yeas. Checks 10033-10056 and payments totaling \$106,257.43 were approved for payment. *Motion* by Rollin with a second by Holmes to approve the August Financial reports with year to date revenue \$492,891.15, year to date expenditures \$259,879.79 and bank balances \$632,677.44 including receipt of property taxes \$99,615.89 and State reimbursements \$13,675.44. Total ARPA funds received of \$142,083.66. Roll call: three yeas.

Chairman Rollin introduced Connie Dombrowski representing Wreaths across America. Dombrowski: Wreaths across America is from Maine with 2.4 million wreaths placed on veteran graves last year. There is no cost to the Township, they give you a press release and the people fund the project. Volunteers place wreaths December 17<sup>th</sup> at noon and remove in three weeks. Rollin: there are 161 graves in Township per Doug Hastings. Combs: some stones have plaques and stickers on them. Rollin: Hastings will help. *Motion* by Rollin with a second by Lamb to authorize *Resolution 2022-39* giving Wreaths Across America consent to place wreaths on Veterans graves. Roll call: three yeas. Further discussion on how the truck will deliver the wreaths and where they will be kept.

#### **COMMITTEE REPORTS:**

**WATER BOARD-** Lamb: meeting is 9/14, will be attending the National Conference in Maryland 9/26-9/29. Holmes: wife called about charges for using credit card to pay water bill and was told the charges were only waived during COVID. Lamb: will confirm that.

**LORCO-** Lamb: meeting is 9/8 with a policy meeting beforehand.

**AMBULANCE-** Holmes: Defibrillator delivered. Lanning: no invoice received yet but did get packing slip. Combs: where do you want it put up? Holmes: we will find a good place.

FIRE- Rollin: meeting Wednesday 9/7, sold truck #152.

**SHERIFF-** August report of 49 incidents in Huntington.

**OPWC / SWAC:** Combs: Talked to Engineer about applying for OPWC and was told Township roads don't score well on applications. Lamb: call Don Romancak with questions on SWAC application.

**ZONING-** Holmes: Lanning gave Zoning Commission and Trustees copy of Grafton Township road standards. Contacted the two people interested in being Zoning Inspector and the Bursley Road resident is not interested in part time. The other is a woman who understands Zoning well, will contact her.

**CEMETERY-** Lanning: Richard McConnell foundation for lot #117 West received and he prepaid for the open / close interment of cremation remains. He will contact Rollin with details of date and time. Balconi monuments emailed questions on Cemetery rules in the Township. A refund for the foundation on lot #102 is prepared for signatures.

**ROADS and EQUIPMENT:** Combs: Roads looking good, reviewing Hawley Road for next year. Lamb: what happened on Stewart Road. Combs: a 4-wheeler did circles and we road graded it. Lamb: recommend either making a Sheriff report or paper file report of the incident.

**RECYCLING-** Lanning: received \$210.00 for .21 ton of aluminum. *Consensus* to set Fall dumpster days at 10/14 & 10/15 9:00 - 3:00.

#### **OLD BUSINESS:**

Lanning: website is very dated, as mentioned previously, a new resident saw the Historical Society information about the museum being open on Memorial Day after the parade. He walked into the empty

building and tried to get access to the third floor. He subsequently called the Township confused. Lamb had issues with myself as gate keeper of the website and Facebook and was supposed to review the website for current information. Lamb: will look over and inform Cravenor (website manager). Wonder how many people visit the site.

#### **NEW BUSINESS:**

Lanning: filed 2021 Local Tax Certification. Rollin: would like to set the Fall Harvest Walk on October 22, 1:00 to 4:00 in the park, asking Dimitri to reserve the pavilion. Checking with Chet/Frans on paying for rental of bounce house. Need a generator for the bounce house. Holmes: will ask Ambulance to attend. Lamb: will ask Rural Water to attend.

#### CORRESPONDENCE/ ANNOUNCEMENTS:

Lanning: given to Trustees= Beaver Wellington 138 kV line project update, Black River Community enewsletter, approved highway use permit, Fall Farm Tour information, Lorain County Health Assessment results & Community Improvement plan meeting, OTARMA Board nominee letter, Transportation Advisory committee meeting, ODOT mileage email and Community Foundation "Connect to a cause", PUCO finding on railroad crossing on Stewart Road. Rollin: should be in place by 8/2023, property owner's driveway will be cut off and we have no say in the matter. Lanning: given to Trustees= Lorain Soil Water Conservation District newsletter (suggest Lamb put on website), Holmes already put it on Facebook. Lamb: will consider it.

#### **PUBLIC PARTICIPATION:**

Tyler Honoshofsky asking Trustees for assistance on culvert pipe installation on Baker Road property. Lamb and Holmes met Honoshofsky recently to discuss the installation and the possible correction of the steep slope to the culvert. Holmes: I paid to have a large amount of dirt taken off to lessen the steep slope to the culvert in front of my home. Honoshofsky: Lamb said he would have a document drawn up by Lanning and there would be some progress. Lamb: I was busy at the Fair and I informed you of things you could do also but you did not. Honoshofsky: this project has been "promised" for more than a year, since the previous roadman reviewed the slope and informed me to proceed with the building of the house and we will address the issue. There has been talk with Rural Water about the depth of their pipes, it will not affect the pipes to remove some of the slope just as it did not on Holmes property. Holmes: let's have Matt come over and see what he thinks and go from there.
