

Declaration for the Increase of an Invalid Pension.

State of Minnesota, County of Washburn, ss:

ON THIS 6th day of February A. D. 1889 personally appeared before me, a Nancy Puller within and for the County and State aforesaid, Ardulalt Rose aged 55 years, of Red Wing P.O. County of Goodhue State of Minn.

who, being duly sworn according to law, declares that he is a pensioner of the United States, enrolled at the Pension Agency at the rate of 12 dollars per month, Certificate No. 283487, by reason of disability from Rheumatism and heart disease

incurred in the Military service of the United States, while serving as Private of Co 2nd Regt Minn.

That he believes himself to be entitled to an increase of pension on account of an increase in his disability and on account of his rate now being unjustly low and disproportionate to his degree of disability consequent upon Rheumatism and heart disease

Claimant desires to be sent to the Board of Surgeons at Faribault Minn for Medical Examination, or to the Board of Surgeons at Mankato Minn for such examination.

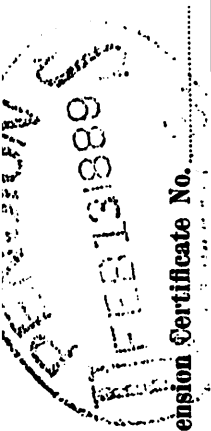
