I like mysteries and will read almost any book put in my hand although Agatha Cristi is getting a little "old."

Julie Zuber, Carmen Grimm and Andrea Haldy serve on the FICCF board and are helping to plan the barbeque. They shared some of the things the group is working on and has helped to support. Give them a call for tickets if you are not online.

Formed initially in 2001 to fundraise for the development and construction of the Lake Iowa Nature Center, it remained active to support conservation/ education and recreation projects across Iowa County. It is a 501c.3 nonprofit with a working board of volunteers from all communities in the county. It has helped to:

- Fundraise to improve Lake Iowa and the Nature Center.
- Provided for educational displays at the Lake Iowa Nature Center.
- Stocked fish at Gateway Park in Marengo.
- Helped bring running water to the scout camping area at Lake Iowa Park in partnership with Boy Scouts and Iowa County Conservation.
- Provided supplies for educational school field trips, summer day camps and camper take home kits.
- Helped Iowa County 5th grades plant trees in partnership with the Iowa County SWCD.
- Paid for food, supplies and speakers fees for Iowa County Outdoor Adventure.
- Provided signage at Iowa County Parks.
- Paid for supplies and speaker fees for many, varied Iowa County Conservation school outreach programs and public programs/events.

If you've not gone to Lake Iowa in recent years now is a good time to visit. Bring your fishing pole and swimsuit too. Hey there's a beach with swimming open to the public through Labor Day from sunrise to sunset. The beach has restroom and water on site.

Lake Iowa Park has picnic areas and camping with 120 "rocked pads" for "RV" camping with electricity, shower houses and a sanitary dump station. Water is available from hydrants in the camping area and at the beach. There are two more rustic, (no electricity) camping areas within a short walk of the shower house. It's all first come, first serve camping.

The 83-acre lake has large mouth bass, red ear sunfish, crappie, perch and catfish. There is a boat ramp with a parking area and a fish cleaning station and yes, the fishing has been pretty good this summer. This a no-wake/no-wave lake, however there is no engine restriction. Yes, you can rent a boat with a trolling motor or a kayak by contacting the campground hosts or the Iowa Lake park ranger.

There are several picnic shelters at Lake Iowa for group picnics. These can be reserved in advance for \$25. There are other group rental options available too at the Lake Iowa Nature Center for a party/event at Lake Iowa.

He would write a letter rejecting the prize because he would have had to travel to Sweden to accept it and then been banned from returning back to his beloved Russia.

Years later one of his sons would accept the prize, but getting the manuscript out and to the masses is another part of the book.

Just for your information, Dr. Zhivago was first put into book form NOT in Russian. It might surprise you to learn what language it was translated into and how it was distributed.

Both books carry the one theme that always angers me - CENSORSHIP.

I dislike it when any individual feels that they know better than another what is or is not best for another. I suppose I'm guilty of this myself because of my distaste of weapons and outright lies.

However when it comes to literature and art I have seen the good and bad. I choose to let an individual choose, even if I disagree.

MY AMANA EXPERIENCE

This week, I took a field trip over to The Hotel Millwright restaurant to meet the new chef. His name is Oscar Jackson III, and he hails from Albany, Georgia. Although he's worked in too many cities to name them all, here are a few – Atlanta, GA; Miami, FL; Orlando, FL; Hilton Head, NC; Savannah, GA; and now Amana, IA.

Chef Jackson started working in the restaurant business at age 14 as a dishwasher and busboy at The Waffle House, and learned from everything he could from the kitchen staff. As a teen, he loved to watch Julia Child's and Justin Wilson's cooking shows on PBS, and still counts them among his gastronomic influences today.

When Chef Jackson had learned as much as he could from his co-workers at The Waffle House, he turned his eye toward climbing the culinary ladder. From 2003-2005, he attended The Art Institute of Atlanta, graduating from their Culinary Arts/Chef Training program. At age 26, Chef Jackson became The Chef at the 12 Hotel Exchange in Atlanta. Other notable restaurants on Chef's resume are Four Seasons Atlanta, Johnny Carino's, and Alligator Soul.

Much like his warm personality, Chef Jackson's approach to cooking is to satisfy both the body and the soul. He likes to use classic ingredients like pork chops or short ribs, and add a special touch or an unexpected (but never unwelcome) flavor to enhance the dish. His aim is to give you all the comfort food with a little dash of inspiration. When I asked what dish or meal is his current favorite to cook, he said it is braised short ribs with a cherry reduction, mashed potatoes, and greens. He told me, "You will never leave hungry." I believe him.

I seem to remember I have an anniversary coming up. I bet I know where I'll spend it.

NEWS RELEASE: ACLUD ELECTION

The annual election for the Amana Colonies Land Use District (ACLUD) trustees will be held Tuesday, October 4, 2022.

Nomination papers are available by appointment only at the ACLUD office at 4304 220th Trail, in Amana. Papers are also available at the Auditor's Office in the East Courthouse Annex at 970 Court Avenue in Marengo between 8:00 AM and 4:30 PM, Monday through Friday.

The deadline for filing nomination papers is September 9th at 4:30 PM in the Auditor's Office.

Please note the polling hours for this election will be from 12:00 Noon until 8:00 PM at the Middle Amana Fire Station.

Voter registration deadline is Friday, September 19th for this election. Pre-registered voters are required to provide an approved form of identification at the polling place before receiving and casting a regular ballot. Voters who are not pre-registered – such as voters registering to vote on election day – and voters changing precincts must also provide proof of residence. A voter who is unable to provide an approved form of identification (or prove residence if required) 1) may have the voter's identity/residence attested to by another registered voter in the precinct, 2) prove identity and residence using Election Day Registration documents, or 3) cast a provisional ballot and provide proof of identity/residence at the county auditor's office by Noon on Thursday October 6th. Election Day Registrant attestors must provide an approved form of identification. For additional information about providing proof of identity and/or residence visit: <https://sos.iowa.gov/voterid> or phone (319) 642-3923 option # 0. Voters are still encouraged to register by September 19th in the auditor's office if your residence has changed.

Anyone wishing to vote absentee before election day may do so by stopping in the Auditor's Office Monday thru Friday 8:00 AM until 4:30 PM starting September 14th, 2022. Voter Registration Forms and Absentee Ballot Request Forms are also available by mail or on the Iowa County website at www.co.iowa.ia.us.
