Classes Offered

ACT 1 is an entry level test that is designed to introduce dog and handler to the agility ring and basic agility obstacles.

Act 2 is the second level and designed to further introduce the dog and handler to the agility ring and additional agility obstacles.

Entries

Pre-trial registration fee per entry \$10

Day-of-trial fee per entry \$15

- Dog may enter both ACT1 and ACT2 on the same day
- Two ACT1 and Two ACT2 tests are offered so receiving a title is possible on the same day
- Exhibitor can fill out an entry form on the day of event between 8:00 AM and 9:00 AM

Who Can Enter

- Any dog that meets the age and physical requirements for a regular AKC agility trial.
- Dog must be 15 months old or older.
- The dog cannot have earned any AKC agility title.
- Non-registered (can be registered day of event) or AKC registered Dogs without registration numbers will be issued a temporary one after the event by the AKC office.
- If a dog handler team has qualified at an event with an unregistered dog they will be sent a query to register the dog after the event.

Performance and Titles

- ACT1and ACT2 titles and certificates will be issued by the American Kennel Club to dogs that are registered with them.
- Title, qualifying and placement ribbons will be presented by WCOTC.

I (we) certify and represent that the dog entered is not a hazard to persons or other dogs. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents, event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge or ACT Evaluator, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog. INSTRUCTIONS

Dogs may be entered in any jump height. There is no Regular of Preferred distinction of AKC's ACT events.

In order to acquire the ACT1 or ACT2 title certificate and have the title added to a dog's record, the dog must be registered/listed with the American Kennel Club. AKC Canine PartnersSM applications may be accepted at the event and submitted to AKC with the event's results.

Dogs that are not AKC registered/listed may be registered at a later date and receive their ACT title at that time.

Dogs listed in the AKC Canine PartnersSM program should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.

Junior Handlers should enter their Junior Handler Number on the front of this form. Should you not have your Junior Handler number, it may be obtained from the American Kennel Club (919)233-9767. If the Junior Handler is not the owner of the dog identified on the face of this form, what is the relationship of the Junior Handler to the Owner?
