## RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT ("AGREEMENT")

## \*NOTICE TO MINOR CHILD'S PARENT/LEGAL GUARDIAN\*

Read this form completely and carefully. You are agreeing to let your minor child engage in a potentially dangerous activity. You are agreeing that, even if Gator Tens For Life, Inc. (GTFL Athletics) uses reasonable care in providing this activity, there is a chance that your child may be seriously injured or killed by participating in this activity because there are certain dangers inherent in the activity which cannot be avoided or eliminated.
