All past due accounts will be assessed a \$35.00 late fee, along with 7.5% per annum interest and a \$15.00 per month collection fee until paid in full. A letter will be mailed after February 15th to all homeowners with past due balances. A certified demand letter, with a minimum \$35 collection fee being assessed to the account, will be sent after March 15th. All past due accounts will be turned

over to the Association's attorney for collection after April 15th. The collection process will be pursued to the full extent of the law, including foreclosure if necessary.
