To the Sherburn and Welcome City Councils,

The department logged 140 calls for service for the month of July. As of August 1, we have logged 759 calls for the year. This is still up over the last two years; however, July was a little slower than the previous months. This, I believe is due in part to the heat in the last month. People were not moving around as much because of the excessive heat and humidity.

The Welcome Festival was a success again this year. The department dealt with a few assault issues on Friday night, but had no major issues on Saturday. The heat again played a factor as the crowd on Saturday night was smaller than normal.

E-Charging will be put in place in the middle of August. This will stream-line the formal complaint process for the area departments as court papers will now be filed digitally. Training is the week of August 15 and the system should be operational by the end of the month.

E-Citation is moving forward and will hopefully be implemented by the end of the year. We just gave the go-ahead with the template design and authorized a committee to research the hardware that we will purchase and install. This whole system is paid for by a \$350,000 grant that the consortium received in 2009. When completed, I invite all of you to stop in and see the system.
