### **Police Powers**

The March 1, 1990 edition of the New York Post contained an article that is of extreme importance to the Christian American Patriot. An edited version of the article follows:

"The Supreme Court yesterday gave police broad new power to conduct sweeping searches after making arrests in private homes. It also bolstered the fight against international drug trafficking and terrorism by giving U.S. law-enforcement agents the power to conduct searches in foreign countries without legal warrants."

"By a 6-3 vote, the justices said U.S. agents did not need a court warrant to search the home of a suspected Mexican drug smuggler later convicted in the killing of a federal agent. The ruling gives U.S. law-enforcement officials broad authority to conduct warrantless searches abroad of non-U.S. citizens. 'The Constitution's Fourth Amendment ban on illegal searches does not apply to non-citizens outside U.S. borders,' Chief Justice William Rehnquist wrote for the court."

"In the domestic case, the justices ruled 7-2 that police may use evidence seized when they arrested a Maryland man accused of armed robbery. Justice Byron White said police may search throughout a house when they have a reasonable suspicion there is a hidden danger to the arresting officers-even if the authorities lack a search warrant and probable cause to believe there is a danger." End of quotes from the N.Y. Post.

This is but one more example and proof that the United States is now entering into the final phase for what the Plutocratic, Ellite-Capitalist, Zionist believe will be their One-World Order. It is fundamental that any government, national or world-wide in scope, must secure its system of law enforcement. We have known for many years that Interpol, the touted international police force, was the private property of these same elitists. Doesn't it seem strange that, all of a sudden, the United States can enter another sovereign country and yank out their rulers? What difference does it make whether the rulers are good or bad? We are accustomed to good and bad (mostly bad) rulers right here at home. How can the United States physically interfere in the internal affairs of Panama, Nicaragua, Columbia, The Philippines or anywhere else without the United Nations or the World Court in the Hague intervening?

A key to the question is that the Soviet Union is joining the 147-nation Interpol (International police coordinating agency) by the end of 1990. The time for the merge is very near and they must have a unified police force. Russia may do it but it will not be for the purpose of furthering the cause of the Plutocrats One-World Government. They will do it because it will be to the best interests of their own dreams of world domination.

The United States, for several years now, has been building a national police force. Each state has, to one degree or another, succumbed to the federal program of uniting the efforts of all police functions (from the town marshall to the state police) with the federal

police and the military. It would be rather difficult for the United States law-enforcement system to become completely integrated into an international one-world police body without first unifying its own system.

## Eliminating Dissension

Reports are being received nearly on a daily basis that indicates the year 1990 to be the beginning of the roundup of what governments have always termed dissidents. It is another indication that the target date for the planned merger of the United States and the Soviet Union is imminent. Of course, the reports are somewhat elusive because it would be stupid for the government to openly announce their intentions in the national news media. However, the reports have enough substance that they should be taken seriously.

Dissidents, throughout history, have come in all manifestations. Some have been openly militant but they have also been classified as dissidents for presenting opposing views. Examples are college professors, teachers, ministers, legislators, labor leaders or just the ordinary man on the street.

Governments, when they have decided to round up dissidents, have always started with those whom people naturally dislike or the scribes have presented in such a way that the average person is indoctrinated into disliking them.

Such is the case with the recent trial and conviction in Dallas, Texas of a group of "Skinheads" for conspiracy to violate civil rights of minorities by allegedly chasing non-whites out of Robert E. Lee park and painting swastikas on a synagogue. From the Patriot's Defense Foundation, 2323 McCue Road, Suite 2, Houston, TX 77056, the following article is extracted:

"The case was important because the government can now prosecute for conspiracy in alleged civil rights violations and there is no need of any accuser or victim."

"Three of the defendants face 25 years in prison and the other two face 20 years each. Under current Federal Sentencing Guidelines, they will have to serve every day; there are no chances for parole. In comparison, a man in California who set his seven year old son on fire with kerosene, served only six years. This is how serious the government feels about so-called 'hate crimes.' Sentencing is set for 'Patriot's Day,' 19 April." End of quotes from the Patriot's Defense Foundation.

It has been reported that the Justice Department released in a Houston newspaper a statement that, if they won the case against the "Skinheads" in Dallas, they would use it as a precedence for an all-out attack on "hate-crimes."

In the May-June, 1988 issue of The Intelligence Newsletter we presented an article on the World Conservation Bank which described how the international money lenders have devised a way to create a world bank with central bank powers (creating money out of nothing like the Federal Reserve System does) and then renegotiating the debts of the nations of the world and accepting their wilderness areas as collateral. Currently, the loans to these countries are not secured.

This evil scheme was brought to light by the work of Franklin Sanders (among others) who publishes The Moneychanger, P.O. Box 341753, Memphis, TN 38184. The following is a portion of an article from The National Educator, March 1990, P.O. Box 333, Fullerton, CA 92632. Read it very carefully.

"On January 9, 1990, at 7:15 a.m., a SWAT team descended on the home of Franklin and Susan Sanders and their seven children in Memphis, Tennessee. Armed with a search warrant, black Ninja uniforms, and signs which said 'Police: U.S. Agent,' five to seven men proceeded to place both parents under arrest and confiscate Franklin's computer."

"Franklin was taken to jail immediately; Susan was given two hours to locate a baby sitter for the children. All were charged with conspiracy to defraud the government, based on 131 overt acts which included: 1. A person closing a checking or savings account; 2. Sanders making a deposit into his checking account; 3. One person making a \$15 check out to cash rather than to the beauty salon its services were paying for; 4. Sanders accused of operating a secret bank. (Actually, he has had a branch of the National Commodity & Barter Association (NCBA) which has been an effort to start a bank based on gold and silver rather than fiat FRNs, Federal Reserve Debt Money.)...Franklin was one of 12 men and Susan one of four women being held against their will and indicted-all from their church. In fact, the pastor of Grace Presbyterian, Rev. Dan Morse, and assistant pastor, Rev. Curtis Crenshaw, were also indicted and being held on the same absurd charge: Conspiracy to defraud the government." End of quotes.

From the same newspaper, another article by Al Benson, indicated that Sanders stated that, by comparison, that a man arrested for molesting two small boys was released on a \$10,000 unsecured personal recognizance bond. Sanders stated that it would appear that our benighted civil government is under the impression that Christians are more of a threat to society than child molesters. (Benighted means to be overtaken by night or darkness. Involved in or due to moral darkness or ignorance. ed.)

## **Noriega, Panama & Bush**

We should all be aware by now of the continuing participation in the world-wide drug business by the plutocratic elitists of the world. Many families of the "Eastern Establishment," also known as the "Boston Brahmins," became wealthy through the drug and slave trade. The evidence continues to mount that the current "war on drugs" is a sham and instead of arresting dissidents, our touted national police force should be making arrests and indicting our leaders at the highest level. Our government is in the death squad business, abroad and at home, and that drugs are being pushed on a world-wide basis for the financial benefit of certain people and for a political purpose. Is that political purpose to stop Communism or is it for something bigger? We know the answer but we always need more facts.

From Lawrence Patterson's magazine *Criminal Politics*, January 1990, we present the following very important article:

"Below is a special report by a Jewish leader, resident of Israel, Dr. Israel Shahak. Dr. Shahak obviously does not accept the Zionist premise, that anything, no matter how heinous and immoral, is justified in the name of international Zionist's aims."

"Dr. Shahak can be of great aid to patriotic Americans because he cannot be slandered with the universally utilized tool of character assassination, labeling those who object as anti-Semitic Hitlerites or racial bigots. Because of this, this report should be given the widest possible circulation by those who are seriously concerned with America's future under the yoke of international Zionism/Trilateralism. Ideally this information should lead to a full blown Congressional investigation of U.S. Israeli ties." (Such a Congressional investigation is most plausible but with the American Israel Public Affairs Committee in control of Congress, this is not very probable.-ed.)

Quoting Dr. Shahak: "It is well known in the U.S., indeed both the Administration and the media proclaim it from the housetops, that Colombia and Panama supply directly and indirectly, a hefty part of the illegal drugs which have become the scourge of American society. What is still largely unknown to the U.S. public, because most negative affairs concerning Israel tend to be covered up by the American media, is the extent of Israeli influence in those two Latin American states."

"An example is the involvement of Israelis, who may have some Israeli government backing, in an important aspect of this hellish business, namely the laundering of U.S. drug money back to the drug bosses of Colombia and Panama, despite all the well publicized efforts of U.S. authorities to intercept it."

"Oddly, citizens of Israel are better informed about this because of two advantages they enjoy over citizens of the U.S.; the Hebrew press, in spite of some recent decline in standards, remains far more open and free to describe the disgraceful affairs in which Israel, Israelis, and American Jews are involved. Such peculiarly American institutions as the American Israel Public Affairs Committee (AIPAC) and its allies don't enjoy in Israel the power they wield in the U.S. The consequence is that much more of the truth about Israeli roles in the drug affairs of the U.S., and the role of those American affairs in the Israeli economy, is known to Israelis than to Americans."

"After direct U.S. govt. financial support of about \$3 billion a year to Israel, the single most important source of Israeli income derives from the export of weapons and so called 'security knowledge' (including the efficient training of death squads). The value of such exports amounted officially to \$1.5 billion in 1988. In reality, the sum is probably even larger. In 1988, one third of this Israeli 'security support,' worth half a billion dollars, went to one country only, namely Colombia."

"With such quantities involved, Israeli 'security exports' had achieved a near monopoly in Colombia by 1988, and this has continued in 1989....Nearly all of the weapons and 'security knowledge' (from airplanes to Uzis), were made in Israel....During the same time Israeli influence was growing in Colombia, exports of Colombian drugs to the U.S. grew as well."

"A similar situation exists with regard to Panama. The right-hand man of Panamanian director Manuel Noriega, and a person who apparently had a hand in putting Noriega in power, is a senior ex-Mossad man, Mike Harari, who has filled Panama with Israeli connections. Since this is a case of a former senior operative of Mossad, it would have been reasonable to expect, at least, a verbal condemnation of Harari from at least one of the many Israeli ministers who make such frequent speeches about 'the danger of the international terrorism' to American audiences."

"Noriega has been accused by American authorities of drug trade on a large scale. One can assume that in a dictatorial regime like Noriega's, Harari is as involved in drugs as the dictator himself. But who stands behind Harari?"

"None have ever found the time to condemn Harari, or discuss his alliance with Noriega, or Israeli involvement in Colombia, with their tame American interlocutors. What is more, it has been reported in Israel, but not in the U.S., that Harari, who often visits Israel and meets with many of the most important Israeli leaders, recently received, after U.S. opposition to Noriega was well known, the honorary rank of Colonel from the Israeli army." (Harari was arrested and released within 48 hours. Why was he released and by whose authority?-ed.)

"Recently reports broke in Israel and the U.S. about a whole group of well-connected former Israeli officers who had provided 'security advice' to one group of Colombian drug lords, whom they described as framers of right-wing opinions. The head of the Israeli group, kibbutz-born Colonel Yair Klein, serves, in addition to his Colombian capacity, as the active commander of the war room of the Israeli chief of staff! I can predict that mainstream American media will not rush to print this, although it clearly would be of intense interest to the American public! It also is interesting to learn that Col. Klein was paid in the U.S. for his services in Colombia. He also was paid in cash."

"Although the sums involved were large (one report claimed it was \$800,000), he did not put the money in a bank (one assumes that he had his reasons), nor did he contravene U.S. laws by taking the cash out of the U.S. Instead, he left the money with a member of a well-known network of ultra pious Jews in NY, who transferred the money to Israel."

"The Hebrew press has voiced the natural suspicion that Yair Klein was paid with money obtained through the sale of drugs in the U.S. by his employers. Was his the only such case?"

"Another network in the U.S., headed by two Israelis, Adi Tal and Dov Feldman, was recently exposed in Edison, NJ, apparently more by chance than by design. It engaged in large-scale laundering of Colombia drug money on both the East and West coasts, to route back to Colombia via Israel."

"In this case as well, several members escaped to Israel. The trial of the remainder, according to the Hebrew newspaper *Hadashot*, presented some curious features. First, it became apparent that the Israelis who headed the gang secured the help of many otherwise respectable American Jews, by telling them the money was intended for the work of Mossad in Panama and Colombia. As a result, a rabbi in Seattle was convicted of receiving some of the money, depositing it in small amounts in many different accounts in Seattle, and then transferring it to a bank in a very small Israeli town, Kiryat Ono. From there, it was transferred to a Colombian drug trader through a Panamanian bank."

"When the gang was brought to trial, the New Jersey court permitted an unlicensed lawyer from Tel Aviv to represent the accused. He did his job very well. Those of the accused who had not escaped to Israel received very light sentences. The rabbi from Seattle got off with one month of detention. The sum which he was convicted of transferring personally to Israel was \$18,300,000, of which \$13,600,000 found its way to Panama. The U.S. media, apparently, was too busy covering 'international terror' to report this case of Israeli laundering of drug money from the U.S. to Colombia."

"This is attributable to the fact that American political life is terrorized to such an extent by AIPAC and similar bodies, and to the continuous attacks on the American media. Presumably readers of *The Washington Report* are familiar with the tremendous harm that this state of affairs does to all human beings (including Israelis) in the Middle East, as well as American interests there. Because the Israeli connection with Colombia and Panama, and the drug industry based in those countries, has such dire effects on the U.S., it is not only the Middle-East, but American society itself that is jeopardized by activities of the 'pro-Israeli lobby' in the U.S." End of article by Dr. Shahak.

The article by Dr. Shahak stands pretty much alone without additional editorializing. It is one more example of the marriage between the plutocrat elitists and the Zionist Jews. As was presented in past Lessons In History, that marriage officially took place at the time of Oliver Cromwell and it exists, perhaps even stronger, to this day. Down through the generations since, they have used the sale of narcotics for a dual purpose. One, to enslave the masses and two, for the purpose of creating wealth beyond all imagination. Those

among them who call themselves Christian must receive the greater condemnation. Those sycophants working for them within law enforcement, government and the "Judeo-Christian" community must share in the judgment that one day will come. (Sycophant means: a parasite, a person who seeks favor by flattering people of wealth or influence; a toady.-ed.)

## Lesson In History Part 7

**The American Revolution (continued).** In [part 6](#) it was stated that it was Augustine who had the greatest influence on how Christian States organized their internal government and how they conducted governmental affairs with other Christian States. It was Augustine (b.354-d.430 A.D.) who developed the Sovereign Christian State.

If we are to understand why the enemies of Christ want to destroy the Christian way of life throughout the world, we must study the system that Augustine was given by God to teach.

It matters not whether we agree with everything Augustine taught as theology. There is probably not a single person who will agree totally with his theology, whether he be Roman Catholic or Protestant. His most important work is unquestionably *The City of God* which was a monumental works of 22 volumes.

Rome had been destroyed by the Celto-Saxon Teutonic tribes. The Pagans of Rome accused the Christians of Rome's fall because Christians abolished pagan worship. They contended that pagan gods were at last venting their wrath. Augustine took it upon himself to reply to the pagan charge, producing his reply in *The City of God*.

For Augustine, there were two major questions concerning the fall of Rome: 1. Why had God allowed this to happen? (Augustine believed in predestination.) 2. Should Christians have recourse to war to repulse the barbarians? Augustine emphatically rejected the notion that Christians were to blame, and demonstrated how Rome, through the sovereign will of God, had fallen because of her own crimes. In answer to the second question, he was emphatic again in justifying the right of Christians to take arms against the barbarians under these conditions: if the object is to vindicate justice and restore peace, if the motive is love, and if the war is just which means that one side must be unjust. Augustine envisioned a world in which the state, through its power of government, even war if necessary, made society a safe and stable place where the church could apply its teachings and principles. With the Augustinian concept of the church applying its teaching and principles for the state government to follow, we can readily see the inevitable battle. Either man is god or God is God.

8. Why the Vatican does not recognize the State of Israel?
9. Why Hiroshima and Nagasaki were "A-bombed" out of existence?
10. Why we went to war in Vietnam, Cambodia and Laos?
11. Why the Iranian hostage situation developed, and the impotence of the U.S. in handling it?

**Background Information.** The science of law is like a patchwork quilt, made up of various seemingly unrelated patches (laws) attached together to make the quilt. However, just as in a quilt, each and every patch has a plan, purpose and limit, yet it is related to each and every other patch in the quilt. The patch is never the quilt.

The science of law consists of filling voids not covered in existing laws, after the voids are discovered. Law "evolves" to suit the needs of the changing times.

In the Jonathan Swift Society report titled *THE U.S. CODE AS INTERNATIONAL LAW*, we pointed out that the Organic Laws of the United States of America, and subsequent laws, were by their nature, International Law. In that report we also noted that there is an aspect of International Law that is religious in nature. Let's look at the religious nature of International Law. "Modern International Law applied/applies only to Christian States."

**International Law.** 'The system of rules which Christian States acknowledge to be obligatory upon them in their relations to each other and to each other's subjects. It is the *jus inter gentes*, as distinguished from the *jus gentium*. (*jus inter gentes* means law between members of a clan united by descent through the male line from a common ancestor and having both a name and religious observances in common. *jus gentium* means ancient Roman law.-ed.) The scientific basis for these rules is to be found in natural law, or the doctrine of rights and of the state; for nations, like smaller communities and individuals, have rights and correlative obligations, moral claims and duties. Hence it might seem as if the science consisted simply of deductions from certain fundamental propositions of natural right; but this is far from being the case, for national intercourse is the most voluntary possible, and takes a shape widely different from a system of natural justice. It would be true to say that this science, like every department of moral science, can require nothing unjust; but, on the other hand, the actual law of nations contains many provisions which imply a waiver of just rights; and, in fact, a great part of the modern improvements in this

code are due to the spirit of humanity controlling the spirit of justice, and leading the circle of Christian nations freely to abandon the position of rigorous right for the sake of mutual convenience or good will.' *Bovier's Law Dictionary* (1867)

**Modern International Law applied/applies only to Christian States.** To put it another way: International Law is Christian principles applied to the conduct and relations of free and independent Christian States. Yes, the Organic Laws of the United States of America, all treaties made by the U.S.; all laws of the U.S.; the Statutes at Large of the U.S.; and the United States Code, are ALL CHRISTIAN INTERNATIONAL LAW by their very nature. Yes, each State of the Union was/is a Christian State, by its very nature. If this were not so, there would not have been any basis in Christian International Law for forming the perpetual union of Christian States, etc. The proof of the Christian nature of International Law is in the documents themselves, and the effects of said documents on history.

**Historical Overview (900-1550 A.D.).** All of the explorers such as Lief Ericson, Columbus, Marco Polo, etc. carried priests along on their expeditions. When they discovered new lands, they claimed these lands in the name of the king or queen, and the Christian Church. Priests were left behind to convert, and minister to, the newly conquered peoples. Small Christian enclaves were created in each and every conquered land. Modern scholars question the motivation behind this practice, but fail to recognize the existing law governing the practice. Actually, the practice was both religious in nature, and very practical as well. Unless these new lands were somehow declared Christian, they were up for grabs by other Christian States. Under Christian International Law, Christian States could neither recognize nor accept Non-Christian ownership of these lands. In other words, the world had to be divided into Christian States, regardless of the beliefs of the indigenous population, so as to conform to International Law as it existed.

**Historical Overview (1550 A.D. to date).** By 1550 A.D., most of the earth had been explored and mapped. An age of colonial expansion had been started, under the principles of International Law, and all Christian Nations were involved in colonial expansion to a greater or lesser degree. The American Colonies are just one example of British Colonial expansion under International Law.

This system of Law developed over a 1900 year period of time. The law made no provision for a Christian State dealing with a Non-Christian State. It worked on the basis of establishing Christian colonies in "heathen" lands to enable "heathen" peoples to come under the control of, and "benefit" from, the workings of Christian International Law. By 1900 A.D., the world had been divided into a series of colonies, territories and protectorates, each controlled by one of the major Christian States (England, France, Spain, U.S.A., etc.). The non-Christian world had no voice in the matter, even though it was fully controlled by Christian International Law.

Since 1900, World War's I and II, and the more recent advances in high tech telecommunications, warfare, transportation, etc. focused attention on a major void in Christian International Law. What was the void?

**The Void.** More than half of the world's population does not adhere to Christianity. There was simply no way to take into account, or deal with, these non-Christian people. This was a long-standing problem, totally ignored by Christian States until after 1900 A.D.

**Why the United Nations Was Created.** By 1900 A.D., the colonial empires were collapsing, for a number of reasons. Non-Christian peoples were beginning to question the propriety of being ruled by Christian powers. The Christian powers were themselves finding it harder and harder to control their far-flung colonies. Change was in the air.



Following World War I, the void in Christian International Law became more evident. The Bolshevik Revolution (1917) changed the government and religious adherence of the Russian Empire, thus removing Russia from the realm of Christian International Law. Great Britain, via the [Balfour Declaration of 1917](#), agreed that Palestine should be a separate state; but, to allow the creation of the State of Israel would have been an exercise in futility. The State of Israel would have been without any protection under International Law, since it was not a Christian State; and the Moslem States would have wiped it out immediately.

Then too, the African States were not Christian, nor were the Asian countries, so the "Third World" could not emerge in harmony with Christian International Law. The problem of conforming the Non-Christian world to Christian International Law was insurmountable. After all, it was not reasonable to expect non-Christian States to accept Christian morality; and conversely, it was not reasonable to expect Christian States to accept non-Christian morality. Either way, an injustice was worked on one party. Then too, the non-Christian world had a form of pagan international law that dated back to antiquity, which could neither be ignored nor conformed.

So, a new concept of International Law was needed to accommodate all parties. In order to be fair to all parties, that new concept had to either include the religious nature of all parties; or be completely devoid of any and all reference to religious principles. We do not know, at this time, whether this new concept is ecumenical or atheistic in nature, so far as its religious nature is concerned. As a practical matter, it ought to be ecumenical, so as to fill the void and compliment Christian International Law. This new concept is the basis for the United Nations.

"United Nations. An organization started by the allied powers in World War II for the stated purposes of preventing war, providing justice and promoting welfare and human rights of peoples. Its membership is made up of nearly all nations of the world. New members may be admitted by a two-thirds vote of the General Assembly. It consists of a Security Council and a General Assembly and subordinate agencies." *Blacks Law Dictionary, 5th ed.* (1979)

"International Law. The law which regulates the intercourse of nations. The customary law which determines the rights and regulates the intercourse of independent nations in peace and war." *Black's Law Dictionary, 5th ed.* (1979)

Take special notice of the fact that the word "nations" is used in the above definitions, instead of the word "States". Since 1900 A.D., International Law appears to have become more encompassing, so that the current definition omits reference to Christian States.

**The United Nations.** The entire world, and the way it functions, has been drastically changed during the past forty-five years. Since World War II, and the founding of the United Nations, the world has once again been divided up. The Christian States have granted independence to their former non-Christian colonies, territories and protectorates in Asia, Africa, Central and South America. No, the world is divided into (a) Christian States that function through age old Christian International Law; (b) non-Christian Nations that function through the United Nations, using the new type of non-denominational International Law; and (c) Christian and non-Christian Nations working through the United Nations.

The United Nations was, and is, the vehicle that enabled the Third-World Nations to come into existence, to flourish, and to function. The U.N. is the "neutral" common ground upon which non-Christian Nations meet, and work out their differences. The U.N. is also the

"neutral" ground upon which Christian and non-Christian States meet, and agree to terms of commerce, peace, etc.

Why did it take thirty-one years (Balfour Declaration 1917 to May, 1948 when Zionists declared the State of Israel) to create the State of Israel? Because the non-Christian State of Israel could not have been created under Christian International Law, so it had to wait until the United Nations had been formed.

Why did the Pope address the United Nations in a plea for world peace? Having already made his plea for peace to the Christian States, the Pope then recognized the U.N. as the official body representing the non-Christian Nations of the world, and asked that all people join forces in the interests of world peace.

Why does the U.S. trade with Communist countries and dictatorships? Under the new concept of International Law, the type of government makes no difference to trade agreements, etc. made within the framework of the United Nations. Business is business, devoid of morality or religious character.

Why were Hiroshima and Nagasaki "A-bombed" out of existence? Because they were the only two Christian cities in Japan. By removing the Christians, Japan became a totally non-Christian Nation that could only function through the United Nations, etc. This helped establish the "new age" of "pagan" international law.

Why did we go to war in Vietnam, Cambodia and Laos? Prior to WW II, Vietnam, Cambodia and Laos were called French Indo-China. France granted independence in the early 1950's. By 1970, Vietnam alone had a Roman Catholic population of over 4 million people, in addition to countless other Christian denominations. This created a problem in how to handle independent Vietnam, Cambodia and Laos under the U.N. and/or Christian International Law. To solve the problem, remove the Christian population by war, leaving only the non-Christian population at the end of the war. Christian U.S. was designated to receive these refugees. If you have a chance to meet Vietnamese, Cambodian and Laotian refugees in the U.S., you may be surprised to learn that they usually are Christians.

**Christian International Law.** The individual states of the union, as well as the union itself, are based upon Christian International Law. This cannot change, or be changed, without changing the nature of the Organic Laws of the United States. If it were decided that we are no longer Christian States, nor any longer under Christian International Law, the basis for all prior law, treaties, etc. would thus be repudiated.

For this reason, Christian International Law governs all acts and actions of all branches of the U.S. government, to this very day. When the supreme Court of the United States ruled that the U.S. is essentially a Christian Nation, it was only reaffirming the underlying Christian nature of international law. For the Supreme Court to have ruled otherwise, would have created worldwide chaos.

The government of the United States makes and enforces Christian International Law as follows: INTERSTATE-Public and private; involving matters between the Christian States of the United States. INTERNATIONAL: Public and private; involving matters between other Christian States and the United States of America.

The government of the United States participates in non-Christian international law through "Multilateral international organizations in which the United States participates." U.S. Govt. Manual 1984/85, pages 689-700. [2](#)

This is the end of the report written and published by the Jonathan Swift Society. There may be disagreement by readers on some of the points made in the report.
