**MONTHLY BOARD MEETING**  
**Monday June 25<sup>th</sup>, 2018**

**Meeting:** The meeting was called to order by Chair Augie Riebel at 7:00 PM. Members present: Augie Riebel Chair, Jane Hurley, Vice Chair, Joe Hickman Supervisor, Debbie Uecker Clerk-Treasurer, Marty Randall Deputy Clerk-Treasure and 9 residents.

**Pledge of Allegiance:** Recited.

**Meeting Minutes:** A motion to accept the May 21<sup>st</sup>, 2018 monthly Minutes was made by Jane Hurley, 2nd by Joe Hickman. Motion Carried 3-0.

**Treasurers Report:** The beginning balance for June 2018 is \$24,630.43, receipts of \$193,095.95, expenses of \$76,739.39 and ending balance of \$140,986.99. A motion to accept the Treasurers' report was made by Joe Hickman, 2<sup>nd</sup> by Jane Hurley. Motion Carried 3-0.

**Old Business:**

1) Roland Epple was present for a CUP for a cluster of entitlements which include a 3 ten-acre lot split plus one 15-acre entitlement. They will have 3 entitlements left on the 300-acre farm site. A motion to approve the CUP for a cluster of entitlements under Wright County's guidelines was made by Jane Hurley, 2<sup>nd</sup> by Joe Hickman and carried 3-0.

**New Business:**

1) Thomas Helmbrecht was present for after-the-fact CUP for a contractor's yard. Thomas will now be residing on the property. A motion to approve the after-the-fact CUP for a contractor's yard was made by Joe Hickman, 2<sup>nd</sup> by Jane Hurley and carried 3-0.

2) Having heard no complaints regarding Douglas and Steve Fykholm renewal CUP for a mobile home accessory. A motion to renew the CUP for a mobile home accessory for Douglas and Steve Fykholm under the same conditions for review in 2 years was made by Augie Riebel, 2<sup>nd</sup> by Jane Hurley and carried 3-0.

3) Having heard no complaints regarding Stuart Marquette renewal CUP for a dog kennel and dog grooming business. A motion to renew the CUP for a dog kennel and dog grooming business for Stuart Marquette under the same conditions for review in 2 years was made by Jane Hurley, 2<sup>nd</sup> by Joe Hickman and carried 3-0.

4) Cheryl Foster, Marysville Township Assessor gave an update of changes, every property will be considered A, B or C depending on different soil types. Each property will be re-drawn and looked at.

5) A motion to pass the ORI resolution 06-2018 was made by Jane Hurley, 2<sup>nd</sup> by Joe Hickman and carried 3-0

6) A motion was made by Jane Hurley, 2<sup>nd</sup> by Joe Hickman to appoint the list of Election Judges and carried 3-0.

7) A motion to renew CD #19878 for a 12-month term at .20% APR was made by Jane Hurley, 2nd by Joe Hickman and carried 3-0.
