IMPORTANT INFORMATION

Parking is prohibited on Hwy. 152 as well as in the driveway that runs across the back of the park. The Los Banos Police Department will routinely patrolling the area and citation will be issued.

Overnight camping is available on a limited bases. No electricity or hookups of any kind will be provided. Camping in your booth space is allowed. **NO SECURITY OF ANY TYPE IS PROVIDED!**

As noted above, booth spaces will be assigned as application and payments are received. Booth space is approximately 15' x15'. Exhibitors are responsible for setup and take down of their own booths. Exhibitors will need to provide their own canopies, awnings, tables, chairs, props, signs, etc. Exhibitors must provide their own generators. **NO ELECTRICITY OR HOOKUPS OF ANY KIND WILL BE PROVIDED.**

Landscaping changes to the park or out of our control and can affect the location of booths. If you require a generator. as a courtesy to the other exhibitors and customers, your booth may be placed in an area that minimizes the noise. Exhibitors providing amusement rides: 1. We do not provide pop-ups, props, tables, signs, awnings, etc. No electricity or hookups of any kind are provided for either booths or RV's. **NO SECURITY IS PROVIDED AND THERE ARE NO REFUNDS OF BOOTH FEES.**
