## Glen Cove Swim Club Pool Parking Procedures

Anyone who lives in the Glen Cove development and wishes to park his/her car in the Glen Cove Swim Club (GCSC) parking spaces, please follow these procedures. - Only households that are current with their pool dues may utilize the pool parking lot.
- To register your vehicles with the GCSC Board of Directors, use the car registration form from the membership section of the swim club website <a href="www.glencoveswimclub.com">www.glencoveswimclub.com</a>.

- There is no limit to the number of cars that may be registered; however, each home will be given two (2) hang tags for their parking privilege. Even if you don't normally use the pool lot, you should register all your cars. Then, when guests visit, you or your guests can park in the pool parking lot.
- If you have already registered your car(s) in a previous year and have your two hang tags, please register again this year so we can keep our database up to date. In addition, once your registration is updated and your 2024 pool dues are paid, then we'll issue you two 2024-2025 stickers for your two hang tags. These stickers will keep your hang tags valid until May 31, 2025. If you lost one of your hang tags and need a replacement, you will be charged a \$50 replacement fee per hang tag.
- **Get your 2024-2025 stickers by May 31, 2024.** Beginning on June 1, 2024, if you do not have the 2024-2025 sticker attached to your hang tag, your hang tag will not be valid and your vehicle will be subject to towing. Towing will be enforced. The car owner will be responsible for paying all towing, storage fees, and any other associated costs.
- Single use visitor hang tags will also be available by request. These tags will be good for one day. - Parking is on a first-come, first-served basis. Keeping this parking lot open and available during the off season is a courtesy, but please note that you are parking at your own risk. The pool parking lot will not receive treatment or plowing during periods of inclement weather in the off-season.

- Open House & Photo Day at the pool on Saturday, May 4, 9am-2pm
- Opening Day of the pool, Saturday, May 25: representatives from the GCSC board will be at the pool 11am-2pm
- Opening weekend of the pool, May 25-27: stop by the pool anytime during operating hours and ask the lifeguards for your parking stickers
- ♦ Memorial Day Picnic, Monday, May 27, 4-6pm: see a GCSC board member
