At 4:00 pm Ed called the meeting to order.

Holly presented documents for signature for several abatements. Bill made a motion to accept the Abatement for Clark and Lagasse. Second by John. All in favor.

John made a motion to approve a refund for Wilbur Cox, Jr whose first half bill was incorrect. Second by Bill. All in favor.
