Jake Phillips with SMCOG oversees comprehensive planning, land use and zoning regulations. Would like to offer on call services for updating Ordinances. Would work with staff to get recommendations to Planning & Zoning and Board of Aldermen. Mayor says marijuana codes need to be updated and that the legislation changed home occupations.

Roe says a few years ago when medical marijuana was approved, we updated our Ordinances and now that recreational has been approved that it is a little more complex and Planning & Zoning discussed it and decided that they weren't comfortable updating the Ordinances and they would like SMCOG to do it. Understands that the attorney went through the contract and made changes.

The intent is for the marijuana and home occupation Ordinances to be updated. Icenhower asks if we have contacted MML. Roe says that no one has. Icenhower says that MML is free and this is \$5,000. Icenhower wants to know if anyone has asked and he would check MML before he jumps on signing the contract. Jake says that they probably would never use the entire \$5,000 but it was his understanding that it is just for the marijuana and home occupation. Beaty asks if we don't use them, will we still have to pay them and Jake said no we did not. Beaty says that we can agree to this, contact MML and if they can't help us then this is in place to get it done. Icenhower asks if it is just for these 2 things. Mayor says it isn't.

Danderson says that ultimately this is a contract to use or not to use. Who will make the call on when they are to be used, Planning & Zoning or Board of Aldermen? Mayor says he can see both. Danderson says for \$45 an hour that if Planning and Zoning wants something approved then it needs to come to the Board of Aldermen for them to make the final decision. Planning and Zoning will need to send a letter to the Board of Aldermen asking them to approve the work be sent over.
