OFFICIAL MINUTES OF THE REGULAR MEETING OF THE BOARD OF WESTON COUNTY COMMISSIONERS, WESTON COUNTY, WYOMING July 18, 2023

The regular meeting of the Weston County Board of Commissioners was called to order by Vice-Chairman Nathan Todd at 9:00 a.m. at the Weston County Courthouse. Commissioners Don Taylor, Vera Huber and Garrett Borton, Attorney Michael Stulken and Clerk Becky Hadlock were present. Denise Thompson led the Pledge of Allegiance.

APPROVAL OF AGENDA

Commissioner Taylor asked to add Budget Hearing Televised under Old Business and Commissioner Huber asked to have Volunteer Boards added under New Business. Commissioner Taylor moved to approve the agenda as amended; seconded by Commissioner Borton. Carried.

APPROVAL OF CONSENT AGENDA

Commissioner Taylor moved to approve the Consent Agenda which included the Minutes of July 5, 2023, Treasurer's Reports, Chairman's Signature on 2023 Joint Agreement to take advantage of an ESRI Small Government Enterprise Agreement, Chairman's Signature on Agreement for Cattle Guard Installation and Relocation on County Road #32 Known as the Thornton County Road, Chairman's Signature on CMAQ FY2024 Dust Suppression Application, Chairman's Signature on Dispatch Joint Powers Agreement, Tax Roll Correction #2598, Board Appointments: Library Board – Debra Piana, Becky Todd; Seconded by Commissioner Huber. Carried.

FY2024 BUDGET – BOARD'S SIGNATURE ON RESOLUTION 2023-20 – ADOPTION OF COUNTY BUDGET FOR FISCAL YEAR 2023-2024

Commissioner Taylor moved to approve FY2024 Budget and approve the Board's signature on Resolution 2023-20; seconded by Commissioner Borton. Carried.

LIQUOR LICENSE TRANSFER HEARING

At 10:00 a.m., a liquor license transfer hearing was opened to transfer the West End liquor license from Rohde Investments LLC to Waite Enterprise LLC. Commissioner Taylor moved to approve the liquor license transfer; seconded by Commissioner Borton. Carried.

OLD BUSINESS

VAULTSIDE

Attorney Michael Stulken let the Board know that Vaultside had counter offered with 20% on a month to month basis. Commissioner Huber moved to take the 20% and request a one year contract; seconded by Commissioner Taylor. Discussion ensued. Carried.

EMS DISTRICT

Judd Dawson, Weston County Health Services CEO, visited with the Board about the EMS District and that Campbell County Ambulance is doing a good job. Discussion ensued.
