Service Agreement

This Letter Agreement (Agreement), effective as of, is between The

1. Description of Service			
SOURCE agrees to furnish a registered masseuse once every other week, dates and times			
to be mutually agreed upon by a representative of SOURCE and ROSEN USA			

SOURCE agrees to furnish a registered masseuse once every other week, dates and times to be mutually agreed upon by a representative of SOURCE and ROSEN USA. SOURCE agrees to furnish all materials necessary for the massages to be administered to ROSEN USA employees. ROSEN USA agrees to furnish space at their 14120 Interdrive East Houston, TX 77032 address for the administering of chair massages to ROSEN USA employees.

2. Advertising

ROSEN USA agrees to assist in the advertising of the services to be provided by SOURCE by:

- a. Allowing flyers provided by SOURCE to be posted in employee common areas as deemed appropriate by ROSEN USA
- b. Sending an e-mail to all employees on premises on the days that SOURCE will be on premises, notifying the employees of the benefit that can be derived from a chair massage and the times that SOURCE will be on premises. SOURCE agrees to furnish the information to be contained in the advertisement e-mails.

3. Compensation and Commitment

In this Section 3., the parties will agree to either A or B below:

A.	SOURCE agrees to furnish chair massages to willing employees of ROSEN		
	USA at a rate of per Payment for the services of		
	SOURCE shall be arranged directly between each of the participating employees and		
	SOURCE. ROSEN USA is not in any way responsible for the payment of services		
	between each participating employee and SOURCE Each participating employee will		
	sign up for the services of SOURCE individually and be financially responsible for		
	his or her chair massage only.		
В.	SOURCE agrees to appear at ROSEN USA 14120 Interdrive East Houston,		
	TX 77032 address for the purpose of furnishing chair massages to willing employee		
	of ROSEN USA. SOURCE will remain on the premises of ROSEN USA for		
	hours and will book massages for up to employees per hour. For the		
	hours that SOURCE is on the premises of ROSEN USA, ROSEN USA agrees to pay		
	SOURCE, regardless of the number of employees that utilize the services made		
	available by SOURCE		
	\$60 per hour for a one year commitment;		
	\$75 per hour for a six month commitment; or		
	\$85 per hour for a three month commitment.		

4. Term				
A. If paragraph 3.A. is chosen above, this agreement will be for a primary period				
beginning and ending Either party may terminate this				
Agreement at any time during the primary period by giving the other party fifteen (15)				
days notice, said notice to be given via (a.) registered mail, return receipt requested, or				
(b.) overnight courier to the addresses specified herein.				
B. If paragraph 3.B. is chosen above, this agreement will be for a primary term as				
specified in paragraph 3.B. beginning and ending, and				
continue month to month thereafter. Either party may terminate this Agreement after the				
primary period by giving the other party fifteen (15) days notice, said notice to be given				
via (a.) registered mail, return receipt requested, or (b.) overnight courier to the addresses				
specified herein.				
5. Payment				
If payment for the services provided by SOURCE under this Agreement are to be paid by				
ROSEN USA, SOURCE will send invoices for the services provided by SOURCE on the				
first of each month to the address provided in Section 6. below. Payment will be made				
by ROSEN USA to SOURCE within 30 days of the invoice date.
