## ASSISTANT CHIEF CAMPBELL'S REPORT

The final inspection on the new ambulance remount took place on April 19 and Alexis Fire is working on outstanding issues that were found.

Pierce came out on May 3, 4 and 5 and provided an in-service training for the new engine. The Maintenance Division is installing the equipment and radios; the engine will be in service in approximately two weeks.

ITR Systems is in the process of completing phase 2 of the Honeywell Access Control system which includes all the remaining exterior doors at all three stations.

#### ASSISTANT CHIEF CIRELLI'S REPORT

We have remained active with the Laraway Communications Center and Will County 9-1-1.

We are still awaiting word on the Assistance to Firefighters Grants for gear extractor/dryer and the joint regional grant for additional dual-band radios.

The Image Trend Continuum used for accreditation is being configured. We anticipate providing updated reports in the next few months.

The Trustees reviewed the April code enforcement reports and the community risk reduction surveys.

# <u>DISCUSSION AND POSSIBLE ACTION ON DEFUNDING ONE ASSISTANT FIRE CHIEF POSITION</u>

Craig Warning, made a motion, seconded by Ken Blank, to defund one Assistant Fire Chief position, upon the retirement of Fire Chief Stephens. Motion passed with all ayes.

## RE-ALLOCATION OF REMAINING U.S. BANK LOAN FUNDS

After funding the engine, ambulance re-mount, 800 Mhz radios and the cardiac monitors, there is \$57,470.52 left of the originally requested \$1,042,000.00.

Craig Warning made a motion, seconded by Dennis Burkhardt, to allocate US Bank loan funds to purchase 11 AED's for use in utility vehicles and station foyers at a cost of \$16,340.06. Motion passed with all ayes.

Dennis Burkhardt made a motion, seconded by Ken Blank, to allocate US Bank loan funds to purchase the final phase of new extrication equipment for the new engine at a cost of \$36,375.00. This will complete the purchase of extrication tools that have been purchased in a multiyear program. Motion passed with all ayes.

## REVIEW AND APPROVE STA. #1 AND STA. #2 ROOF REPAIRS

During the February snow and ice storm, Station 1 and Station 2 suffered some damage to the roofs and gutters. The money received from the insurance company will cover MECO Roofing to repair the damage as well as removing worn out screws on the eave at Station1. Robert Hennessy made a motion, seconded by Ken Blank, to approve MECO Roofing to repair the roofs as stated above. Motion passed with all ayes.

We will need to budget for snow bars to be installed for Station1 and Station 2, which will be approximately \$7,000.00.

#### **CLOSED SESSION**

Robert Hennessy made a motion, seconded by Dennis Burkhardt, to enter Closed Session at 8:08 PM to discuss personnel issues. Motion passed with all ayes.

The Board returned to Open Session at 8:19 PM.

Robert Hennessy made a motion, seconded by Dennis Burkhardt, to start the process to promote one Lieutenant and one Engineer. Motion passed with all ayes.
