DID YOU KNOW?

Carving pumpkins, trick-or-treating, and wearing scary costumes has its roots in the ancient Celtic festival of Samhain (a Gaelic word pronounced "SAH-win"), a pagan religious celebration to welcome the harvest at the end of summer. People lit bonfires and wore costumes to ward off ghosts.



In the eighth century, Pope Gregory III designated Nov 1 as a time to honor saints. Soon after, All Saints Day incorporated some of the traditions of Samhain.

The evening before All Saints Day was known as All Hallows Eve, now Halloween.

Locally, these traditions have merged with the Latin customs that combine indigenous Aztec rituals with Catholicism brought by the Spanish Conquistadores. (Dia de los Muertos is celebrated on All Saints Day in the Catholic calendar).

This tradition implies that the dead would be insulted by mourning or sadness, so the holiday celebrates the lives of the deceased with food, drink, parties, and activities the dead enjoyed in life. It recognizes death as a natural part of the human experience, a continuum with birth, childhood, and growing up to become a contributing member of the community.











On Dia de los Muertos, the dead are also a part of the community, awakened from their eternal sleep to celebrations with their loved ones.

The most familiar symbol of Dia de los Muertos are the Calaveras (skeletons and skulls), which appear as candied sweets, parade masks and face paintings, and decorative dolls. www.nationalgeographic.org

O'SIDE TRANSIT CENTER TRAFFIC IMPACTS!

NCTD has submitted a Draft Environmental Impact Report (DEIR) to the City for development of the Oceanside Transit Center (OTC) with a 7 Story, mixed use project including commercial, apartments, parking, a hotel NCTC offices and updates to the transportation hub.

OCNA is reviewing this document and found some major impacts to our neighbors around this project! Key issues are:

- Routing dozens of buses and 1000+ additional cars on our small streets (Michigan and Missouri) creating safety hazards for pedestrians and cyclists!
- 2) This routing *will wipe out our limited street parking* for our residents and businesses like ACE Hardware and Local Tap House (LTH).
- 3) **NCTD has not done proper traffic analysis** to identify and correct the impacts of 100% increase of traffic!
- 4) This *creates a HUGE air quality and noise problems*. The trains may have to blow their horns up to 10 times per arrival and departure!

***PLEASE email these concerns to Rob Dmohowski, Principal Planner at rdmohowski@oceansideca.org Let him know all bus traffic needs to enter from Seagaze to Cleveland, and exit on Michigan to Tremont, and north to Seagaze, the only street wide enough for these huge buses!

Public comments close noon on Oct 18th.
