- Meeting called to order at 8PM by Commissioner Rubio

- Attorney Braslow noted this meeting was duly advertised as required
- Attorney's report
 - Both Mr Braslow and Administrator Rauch continue to reach out to the managing company of the cellular tower regarding their changes to the financial agreement between the company and the Board. These changes were not agreed upon nor discussed prior to the change by the management company. Mr. Braslow will try again. If no response a certified letter will be sent.
 - The required mail in notice for the upcoming election (shared by all fire districts in Jackson) will have to be resubmitted and updated due to the Governor's Executive Order moving the Fire District Election to April 20th.

- The NJ DCA Director Meloni Walter has stepped down. The new Director is Jacquelyn Suarez.
- Due to the Governor's Executive Order allowing a change in the Fire District's temporary operating budget from 14% to 30%, there would need to be resolution adopting this change.

- Administrators report
 - Administrator Rauch presented a written report to the Board for the Month of December 2020 outlining:
 - Calls for service for both the Whitesville and Cassville Fire Stations as well as the career staff at both stations.
 - Continuing property work at the Miller Road fire house and the South Hope Chapel Road fire house.
 - The LOSAP qualification notice was sent to each Fire Chief as well as the Board members.
 - Service and repair work status on fire service vehicles as well as a rough time of delivery of the new ladder truck for the Cassville fire station (about February 2021).
 - To date, OCCares has reimbursed the District in the amount of \$6,600 for COVID19 costs. Rauch has submitted further costs for overtime expenditures and sick time for possible reimbursement as well.
 - Rauch would also like to discuss a proposed policy for return to work from a COVID19 illness and/or exposure.
 - Also submitted was a review of activities for the Fire Bureau for the month of December 2020 including fines, violations and fees.
 - In addition to his written report he reported that front tires were replaced on tanker 5608, new Cassville brush truck is at the paint shop, vehicle 5610 will be going to the body shop for minor repair, photos of the new ladder truck are here for review.
 - FYI the Jackson Township Construction Official has retired and the Fire Sub Code Official has tendered his resignation.
 - Replacements are being considered.

- Reports by Whitesville Fire Company Officers and Cassville Fire Company Officers
 - Cassville Chief Poppe Jr.
 - Headlight repair was made to Chief's vehicle.
 - Inquiry into the new Ford Chief's vehicle for the Cassville Station.
 - Purchas order was completed and sent to Buyer's Ford to order the vehicle.
 - Chief Poppe Jr and Capt Bonner Sr will move forward with the needs and construction for the interior lay out of that vehicle.
 - Inquiry for one of the FF's who attended fire training; will he be reimbursed for mileage?
 - Some years ago the Board stopped the practice of using District vehicles for FF's attending FF1, FF2 or other such training. It is believed that the Board also agreed to reimburse mileage for the FF's.
 - Commissioner Km Flemming asked Chief Poppe to have the FF making the request submit it in writing identifying the training and travel.
 - The Board will also research the minutes of the past to locate the meeting where this reimbursement was approved.
 - Further requirements will need to be outlined.
 - Chief Poppe Jr mentioned the need for our FF's to use the vehicles under their control with respect for the District. Comment was made to him that 5790 vehicle was parked outside the liquor store at East Veterans Hwy. and Hope Chapel Road.
 - Commissioner Km Flemming indicated he would address this issue.
