Equine Activity Release and Hold Harmless Agreement

In exchange for being permitted to participate in the above-referenced activities, the undersigned Participant hereby releases and forever discharges QUEENY PARK EQUESTRIAN EVENTS, INC., ITS DIRECTORS, MEMBERS, VOLUNTEERS, EMPLOYEES, OR GUESTS; MID-ILLINOIS SPORT HORSE ORGANIZATION (“MISHO”), ITS DIRECTORS, MEMBERS, VOLUNTEERS, EMPLOYEES, OR GUESTS; JILL O’DONOGHUE, HER HEIRS, EXECUTORS, ASSIGNS, OR ADMINISTRATORS; ST. I will defend and keep those released by this agreement free of any damages or costs because of any such claims including all causes of action brought by my guests who have not signed a waiver. It is acknowledged and agreed that the “any claim of any kind” provision stated herein is not merely a recital, but is contractual and the parties expressly acknowledge the enforceability of the provision under Mo. Ann. Stat. § 537.325 and any other applicable law[s]. This Release is intended to be, and is, the broadest release allowed under the law.
