

PLANNING BOARD - 2/17/2022

(Rescheduled from 2-02-2022)

Chairman Dick Frasier, Board Members Judy Gourley, Meg Haskell, and Pam Peterson were present. Alternate Martin Fitzgerald, Sr. was absent. There is one vacancy.

DIDONATO (43.17-1-14) 33 Jenkins Point Drive (TR-1)

The applicant is proposing a five-bedroom house on a vacant lot, which is also in the sewer district. The new construction would be within 100' of the Mean High-Water Mark (MHWM). The proposed location meets the town code setbacks of 50' from the MHWM, ten feet from side lines and 25' from wetlands. A public hearing was held. A letter against the project was read expressing concern about protecting the shores of Lake George from over development and stated that the lot was deep enough to place the structure 200' from the MHWM. A representative for the applicant indicated no variances are being requested, the structure location was set to avoid the wetlands on the property, and the lot was designated a buildable lot at the time of purchase. All permits have been approved. This lot was previously subdivided as a building lot. The application was unanimously approved with the request that property bounds are clearly marked for the duration of building process.

HABER (60.9-1-46) 12 Bobkat Lane (TR-1)

The applicant is proposing a renovation and second-story addition to an existing one-story structure. The new construction would be within 100 feet of a stream, pond, river, or lake. The applicant also plans to build a detached two-story two-car garage, with storage on the second floor. The existing deck just meets the 50-foot setback from the Mean High-Water Mark (MHWM). The proposed deck setback would remain unchanged. All other setbacks would also be met. The applicant requested tabling of the application while waiting for results of the Arcady Bay Homeowners Association approval review.

ADK Hide-Away LLC (25.1-1-1.12) 346 West Hague Road (OC-1)

The applicant is proposing a two-lot subdivision of a 55.69-acre parcel to be a 4.43-acre parcel and a 51.26-acre parcel, respectively. The application was deemed complete and a public hearing was set for the next Planning Board Meeting on March 3, 2022. A site visit was deemed unnecessary.

ZONING BOARD OF APPEALS - 2/24/2022

The February meeting of the Zoning Board of Appeals was canceled due to a lack of submissions.

PLANNING BOARD - 3/3/2022

Chairman Dick Frasier, Board Members Judy Gourley and Pam Peterson, and Cathy Clark (acting for ZEO Matthew Magee) were present. Meg Haskell was absent. There is one vacancy.

ADK Hide-Away LLC (25.1-1-1.12) 346 West Hague Road (OC-1)

The applicant is proposing a two-lot subdivision of a 55.69-acre parcel to be a 4.43-acre parcel and a 51.26-acre parcel, respectively. The public hearing scheduled for March 3rd has been postponed until the April 7th Planning Board Meeting.

HABER (60.9-1-46) 12 Bobkat Lane (TR-1)

See details in the Planning Board report for 2-17-2022. This has been tabled until the April 7th Planning Board Meeting.

MICHELS (60.5-1-24 & 60.9-1-24) 73 & 77 Pine Cove Road (TR1)

The applicant currently owns two adjoining lots, each with a single-family, non-conforming dwelling. The owners propose removing both existing structures, merging the lots, and constructing a new single-family six-bedroom house within 100 feet of the MHWM, along with a three-car garage, with a second-floor artist's studio and half-bath. Per the request of the applicant, the Planning Board reviewed and provided comments as to the approvability of the proposed project. The board requested overall dimensions of the proposed structure's footprint, locations of planned vegetative clearings and planned plantings including along the lake, and a rendition of the view of the structure from the lake that includes vegetation. The board expressed concern about the visual presentation of a house of its size from the lake and the storm water runoff from the proposed driveway. A site visit was set.

TOWN BOARD - 3/8/2022

Supervisor Edna Frasier and Board Members Steve Ramant, Jack Bast, Maureen Cherubini, and Josh Patchett were all present.

A moment of silence was held for John Brown, Herman Rogg, and Marianna Klein.

A public hearing was held on a request by the Pickerel Bay Association in Huletts Landing to allow placement of buoys in Sunset Bay. Representatives of the association urged approval, as did Councilman Ramant, who said it was a simple request for safety in the bay. Councilman Patchett reiterated his concern that this and other applications for buoys were so that residents of the areas could mark off "their own little areas of the lake." The request was approved.

Donna Wotton, Executive Director of the Ti-Alliance and Hague resident, discussed a new childcare survey. With a serious shortage of childcare throughout the entire North Country, they are seeking to build an accurate picture of the childcare needs of our immediate community. Two goals are to create a new public childcare center open and affordable to all residents, as well as develop more home-based childcare providers. Good data is critical to working on this problem and getting funding to support the effort.

operation to a major plastic injection molding company in Cranford, NJ.

Herman always had a passion for automobiles and one of his first cars was a 1940 Lincoln Continental convertible that he purchased in 1951. Herman met his wife, Nadine Warner, in 1952. The two courted and later honeymooned at Lake George and Niagara Falls in the Lincoln. The Lincoln remains in the family to this date. Amazingly, the Lincoln became practically a part of the family as it was utilized at their major life's events, including bringing their two children home from the hospital and at weddings. The car has been used for annual vacations touring the United States in antique car caravans with the Classic Car Club of America. Herman went on to collect and restore several other classic cars, though the Lincoln was always his favorite.

Thirty-four years ago, Herman and Nadine purchased a fixer-upper camp in Forest Bay, where they resided every year throughout the spring and summer months. Herman was a brilliant handyman, having the skills to repair or build practically anything. The restoration and remodeling of this home was quite a project. The camp was eventually transformed into the true Adirondack style. Herman also enjoyed tinkering with birch bark, sticks, and twigs, creating decorative items and furniture for the camp.

Herman was always a loving, happy, and generous husband, father, and grandfather.

He was an avid golfer, belonging to Torrington Country Club in CT and the Ticonderoga Country Club.

Herman is survived by: his wife of 67 years, Nadine Rogg; his son, Douglas Rogg; his daughter, Cynthia Baldwin; four grandchildren, Kyle and Ryan Baldwin and Kevin and Stephanie Rogg; and his great-granddaughter, Arianna Checchetto.

Herman's ashes will be interred in Valley View Cemetery in Ticonderoga sometime this summer.

DIED: John M. Brown, Jr., 93, peacefully, in his apartment in

Saratoga Springs, on February 21, 2022, a few weeks short of his 94th birthday.

He was born in New York City to devoted parents John Muir Brown and Gabriella Bacon Brown. A few years later, his parents moved the family to Hastings-on-Hudson, where he and his three brothers went to school.

John went to Cornell University. After his first year, he took a sabbatical to work as a laborer, foreman, and eventually, a director at Alexander Smith Carpet



Company. Three years later, he returned to Cornell to finish his Bachelor of Science degree in Industrial and Labor Relations, where he met Joanne Burford, the love of his life.

In June 1955, just a few weeks after their graduation from Cornell, John and Joanne were married in Teaneck, NJ and they honeymooned in Silver Bay.

John started his professional life as the Assistant to the Dean of Men at Cornell. He later became Director of Academic Advising at SUNY Binghamton, Harpur College.

In 1962, he earned a Master of Arts at Colgate University, while Joanne taught in a two-room schoolhouse. They returned to Ithaca in July 1962, where he took on the role of Dean of Students at Ithaca College, a position he held for 30 happy years, retiring in 1992.

During his tenure at Ithaca College, he achieved a Doctorate of Education from Cornell in 1969.

Dean Brown hugely enjoyed working with the students at Ithaca College and kept in touch with many of them for years after retiring. By modeling kindness, integrity, and humor, he encouraged his students and those around him to always be the best versions of themselves.

Following his retirement, John and Joanne moved from Ithaca to their summer home in Silver Bay for many happy years in the "North Country." While Joanne was still working as the Principal of Ticonderoga Elementary School, John threw himself fully into the local community. He delivered Meals on Wheels – delivering to the (in his words) "old folks," long after he surpassed most of them in age. He was an ambulance driver and member of the Zoning Board of Appeals for the Town of Hague, served as a member of the Ticonderoga Festival Guild Committee, and became a deacon of Putnam Presbyterian Church, becoming renowned for making the best coffee cake for the coffee hour that followed the services.

He viewed one of his biggest accomplishments post-retirement, as the founding of "The Poopies" group in Silver Bay. One day, John and his good friend, Kay Barton, were sitting in the Poopies Diner in Glens Falls, when they realized that there were many other locals like themselves, who would enjoy going on interesting cultural excursions together. Having identified this need, John and Kay started "The Poopies," with John taking on the role of "Major Poopie" - often abbreviated, to his eternal amusement, to "Major Poop." They organized outings to concerts, garden tours, theater events, talks, lake cruises, and more. There was always a meal at each event, so people could come together to enjoy one another's company. It was a welcome lifeline for the rural community and remains a thriving social group to this

John always said, "Exercise is hazardous for your health," and was a firm believer that "people should sit down and smell the roses." He was continually perplexed by his brood of extremely athletic offspring – although he was always their biggest supporter from the stands and throughout his life.

John was all about family and nurturing. His children always brought him enormous joy: Andrew, Elizabeth, John, Geoffrey, Susan, and Thaddeus (Tad). He loved playing the doting grandfather to his eighteen grandchildren and to his great-grandchild and he was also very close to his entire extended family.

An avid gardener, his summer beds were legendary and he was particularly known for his fabulous zinnias. John was always happiest on his deck, overlooking his

garden and Lake George, while chatting and laughing with family and friends.

John was a big-hearted, loving, and much-loved husband, father, grandfather, and great-grandfather. He held a lifelong devotion to education that continued well after his professional life ended and he remained a passionate lifelong volunteer. John cared first and foremost about people, people's stories, and his community.

John was predeceased by: his wife, Joanne; and brothers, Don and Bill.

He is survived by all of his offspring and his brother, Robert ("Uncle Bob" to everyone).

The celebration of his life will take place this summer.

Under Committee Reports, Matt Coffin reported for the Highway Department about a new truck for the Highway Department, new employees, and a possible new working hours structure involving going to a ten-hour day, four days a week. This will be further discussed by the board.

Councilman Bast reported for the Personnel Committee that Cathy Clark, retired ZEO, will be an assistant to the new ZEO for eight hours per week.

There was a long discussion about the location for a proposed bandstand at the Hague Town Park. Councilman Patchett suggested that it should have a craftsman appearance and be in an area where it would not obstruct the

lake view. Councilman Ramant felt the proposal to place it near the lakeside would offer audiences the opportunity to look at the lake instead of at the visitor center. WATER QUALITY MATTERS

It's hard to think about water quality Dedicated to when the world is **Protecting** focused on the the Water events transpiring in Quality of Ukraine and a Lake George madman in Russia has his finger on the nuclear button. Boy, are we lucky to be living in this country!

But life goes on, and progress is being made on protecting Lake George water quality. The ad hoc Septic Systems Committee of the Lake George Park Commission (LGPC), which is working to put a framework together for a septic inspection program, has been holding monthly meetings since July. Supported by a technical committee that includes representatives from state agencies, local and county government, businesses and the LGA, as well as professional engineers, the committee fully researched the issues. In December, they presented their proposal to the full LGPC and, in January, the commissioners voted to move forward with it. Here are some of the key elements of the proposal being considered:

- Properties with septic systems within 500 feet of the Lake George shoreline or within 100 feet of DEC-regulated streams would be impacted. This amounts to about 2,800 properties. Letters have gone out to these property owners for their input and the LGPC staff is responding to questions.
- Inspections would take place every five years, meaning that one-fifth of the properties would be inspected each year.
- Trained inspectors working for the LGPC would be used. This might require two or three seasonal inspectors, plus help from LGPC staff.
- · A fee schedule is being worked out, but the affected property owners would likely pay \$50 annually to cover the cost of inspections. Commercial properties would pay double that amount. Properties with holding tanks could have a lower fee schedule since they are easier to inspect.

- · If failing or substantiallynoncompliant systems are found during an inspection, they would need to be fixed within six months. Substandard systems would need to be replaced before the next inspection.
- **Enhanced Treatment Units have** their own inspection and maintenance contracts, so inspection by the LGPC would not be needed.
- Public hearings on the proposed regulations are expected in late summer or fall of 2022. Final regulations would be implemented in 2023, if the regulatory process is completed on schedule.




She graduated from SUNY Binghamton with degrees in Environmental Studies and Economics.
