ARTICLES OF AMENDMENT To ARTICLES OF INCORPORATION THE LOVE OF LEARNING, INC.

Pursuant to the provision of Section 617,1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles on amendment to its articles of incorporation

FIRST: Amendments adopted (indicate article number(s) being amended, added, or deleted)
