# Some things that come in Threes

Threesomes, three's a crowd, sides of a

triangle, meals in a day, and so on. This was the start of my first offering, and was well on its way of being complete, until... The events of the day (civil unrest, law enforcement under attack, the Pandemic) now caught my attention and caused me to begin work on something that was non-political in emergency management to say with my try number two, until... California caught on fire, and I realized an army of First Responders were suddenly being mobilized. And then, what came to be known as the Valley Fire, hit San Diego. I, like most of you, felt the urge to somehow respond to the need. However, the pandemic, and the latest county emergency plan, as to who could be called by government agencies, left me with the feeling of being unrecognized and a level of frustration. Don't you feel the same? So here we are at try three.

That leads us with the need to explore how we can somehow support the efforts of those that are responding; that's part of what we are trained to do. I feel that I have neither the necessary knowledge, and no longer the needed strength and endurance fight fires, however, we are trained and most of us have the experience to support most agencies, and their workers that work within the fire area. Perhaps we should look at this as an opportunity to reach out to these agencies (and others?), when things calm down, and suggest there might be something in their operation that we could support.

Some of the things that come to mind might be:

1. Provide a radio operator with a

- field worker(s) to allow them freedom from any radio distraction, to performing their work.
- 2. Provide a control point for Internet agency communications.
- 3. Provide situation reporters and observers.
- 4. Support through relieving other radio operations.

Because of whom we are, trained in various aspects of emergency response and human need, each of us is free to decide how we can help others in need or peril. There is a line we must be careful not to cross. As a member of Southwestern REACT you are not acting in behalf of the Team, unless the Team is called out by a response agency; basically you are unsolicited volunteer. Be smart on how you present yourself.

During major emergencies, such as the Valley fire, one or more amateur repeaters establish themselves as clearing houses of information. Different stations will monitor a selected media source, while others listen to the more active channels information. RUMOR CONTROL starts here. Treat and preface all information received as "It has been reported, but not verifiedthat ...". Live television reports may be a reasonable exception (if viewed by you). To quote Sgt. Joe Friday, of "Dragnet" fame, "Just the facts ma'am".

From the first day you entered the team, we emphasize this is a <u>Team</u>, and what we do must be a Team effort. So, with your free time, get up off your COVID-19 Couch and help us find a way or ways to get in to the action and do the job we joined to do. There is a job to be done and we are the best to do it. I hope you are hearing me.
