Mary Whiteford was here to introduce herself, she is running for State Representative. She is also a resident of Casco Township.

Public Hearing: Allan explained that the purpose of public hearing is to receive public comment concerning the Township's consideration to submit for a Michigan Natural Resource Trust Fund Grant on April 1, 2014 for funding to construct additional parking and a connection walkway in the Casco Township Nature Preserve.

Pam handed out a graph of the preserve showing the extra parking spaces. We would like to resubmit for this grant again. Pam reported that the beach stairs are complete. The walkway will be in this spring. Judy asked about the porta potty if it is in the grant? Pam said it wasn't in the original grant. Tom Jessup is concerned about this not being enough parking?

Resolution of Authorization to Provide Parking For Lake Michigan Beach Access and Blue Star Pathway at the Casco Township Nature Preserve

RESOLUTION NO. 031714-06

WHEREAS, Casco Township supports the submission of an application titled, "Parking for Lake Michigan Beach Access and Blue Star Pathway" to the Michigan Natural Resources Trust Fund for the development of parking and walkway to provide public access to the newly constructed Lake Michigan beach access stairway at Casco Township Nature Preserve, and the parking will also serve the Blue Star Pathway to be constructed in 2016; and,

WHEREAS, the proposed application is supported by the Community's 5-Year Approved Parks and Recreation Plan; and,

WHEREAS, Casco Township has made a financial commitment to the project in the amount of \$25,532.00 matching funds, in cash; and,

NOW THEREFORE, BE IT RESOLVED that Casco Township Board hereby authorizes submission of a Michigan Natural Resources Trust Fund Application for \$72,688 (74%) and further resolves to make available its financial obligation amount of \$25,532 (26%) of a total \$98,200 project cost, during the 2014-2015 fiscal year.

Allan made motion to approve payment of Oselka Inv.in the amount of \$11,025.84. Lu seconded.

Discussion on a ribbon cutting ceremony in August for the stairs.

SHAES did a great presentation of a flag system on the beach and contract for this flag system with SHAES was approximately \$8,000.00. The committee is going to look at other options also.

Seniors report Rachel Brenner gave a report on the activities and future programs.

County Report Tom Jessup, County Commissioner, gave a brief report.

Old Business-

Water/Sewer Authority gave a brief report on finances.

Roads- The roads decision was tabled for Sat. March 22, 2014 @ 8:30 am to make decisions on what were going to do for 2014.

Lakeview Water Loop – Letter from SHAES Deputy Chief, Tony Marsala Sr., addressed the question of water flow. Explained that looping the line at Boardwalk would increase the amount of water available to the fire dept. SHAES encourages the board to have this line, and similar lines looped when possible.

The cost for the Lakeview looping would be approximately \$30,000 to \$40,000. This will be decided on Sat. morning March 22, 2014 meeting.

Snowplowing - Bill Sill was asked to submit an invoice of extra work he has done because of this rough winter. His snowplowing contract amount has always worked in the past but this was a different winter than usual.

Allan moved to pay an additional payment to Bill Sill. Lu seconded. All in favor. Motion carried.

New Business-

Special assessment bank financing terms from Chemical Bank for Orchard Dr in Miami Park for the amount of \$173,116.25 to be repaid in annual installments over a period of

fifteen years with the first principal and interest payment due one year from the closing date. Judy made motion to accept the financing for Orchard Dr Sewer. Lu supported.

Motion made to adjourn. Lu seconded. Meeting adjourned at 9:25pm
