#### MANAGEMENT SUMMARY

The North Carolina Department of Transportation (NCDOT) proposes improvements and upgrades (widening, grading, paving, and realignment of curves) to a 9.98-mile segment of US 70 (Burlington Road) between SR 3045 (Mount Hope Road) in Guilford County and SR 1309 (Westbrook Avenue) in Alamance County, North Carolina. The improvements may include a possible highway bypass to the north or south of the National Register of Historic Places (National Register or NRHP) -listed Palmer Memorial Institute (PMI) Historic District in Sedalia (a state-owned historic site) and the NRHP-listed Dr. Joseph A. McLean House at 6609 Burlington Road, Guilford County. The US 70 improvement project is state funded and requires a U.S. Army Corps of Engineers (USACE) permit. This report represents the documentation of historic properties located within the Area of Potential Effects (APE) for architectural resources for US 70 (TIP Nos. U-2581B/R-2910).

NCDOT established an APE for architectural resources extending 1,000 feet from the outermost construction limits on each side of US 70. The APE also includes a study area north and south of the NRHP-listed PMI Historic District and the NRHP-listed Dr. Joseph A. McLean House for a possible bypass. In April 2012, TRC Environmental Corporation (TRC) architectural historian Geoffrey Henry and Cultural Resource Analysts (CRA) architectural historian Hallie Hearnes conducted an initial survey of architectural resources 50 years or older within the Project APE. Fifty-nine (59) resources were identified, mapped, and photographed during this initial survey. No potential NRHP-eligible rural historic landscapes were identified.

On June 12, 2012, TRC submitted the survey results in a presentation to the North Carolina Historic Preservation Office (NC HPO) and NCDOT. At that consultation meeting, 42 of the 59 identified resources were determined not worthy of further evaluation for the NRHP (Appendix A). Photographs of those 42 properties are included in Appendix B. NC HPO and NCDOT requested an intensive survey and NRHP evaluation of 15 properties (five of which were to be evaluated as a potential historic district), as well as updates to NRHP nominations for two properties.

Finally, NC HPO and NCDOT requested that TRC update the nominations for the NRHP-listed PMI Historic District (NCDOT Survey #41, GF-0180) and Dr. Joseph A. McLean House (NCDOT Survey #45, GF-1535). An intensive survey of these architectural resources was conducted by Geoffrey Henry (TRC) and Hallie Hearnes (CRA) in September 2012.

As a result of the intensive survey, TRC has made the following NRHP recommendations:
