Teaching approaches may be defined as a set of beliefs, values or concepts that can be integrated into a classroom more about the nature of learning. (Examples of teaching approaches may be teacher-centered, learner-centered, subject-centered, etc.).<sup>5</sup> The teacher<sup>6</sup> is seen in the teacher-centred approach as the only trustworthy source of knowledge as opposed to the learner-centred approach<sup>7</sup>. Student Centric TLE approach is effective for teaching because they have become investigators who can reap the benefits of their creativity to solve real-world problems this become effective when students take responsibility for their learning.
