## **LCLCE Summer Institute Brings Back "Order in the Court"**

The Louisiana Center for Law and Civic Education (LCLCE) conducted several professional development programs for Louisiana teachers this past summer.

In addition to back-to-school workshops for educators in Lafayette, Jefferson and St. Tammany parishes, the LCLCE held the Louisiana Summer Institute, a four-day teachers' workshop (provided at no cost to teachers) offering instruction in, and free textbooks for, "We the People, the Citizen and the Constitution," a nationally acclaimed law-related education course.

As an adjunct to the Summer Institute, the LCLCE brought back "Order in the Court," taught by a distinguished faculty of Louisiana state and federal judges, administrative law judges and/or hearing officers. The program provided attendees with a better understanding of the various courts in the judicial system and offered further insight into the structure of the government. Twenty-nine teachers representing seven Louisiana congressional districts at the elementary, middle and high school levels participated.

The "Order in the Court" program was hosted at the Louisiana Supreme Court Building in New Orleans. The faculty included Hon. Pascal F. In addition to expert pedagogy sessions, the "We the People" program included a seminar by constitutional scholar Carl Richard, Ph.D. The programs culminated with the educators creating a simulated U.S.
