Approval of minutes: R. Guyer motioned to approve the December minutes. L. Maxwell seconded this motion and the motion carried.

Financial Report: Finances seem to be on track. G. Ferguson stated he will need to gather more information on bridges to finalize material cost. Ferguson stated a community meeting will be held in March.

Condo Association Meeting: No report this month.

Work orders: G. Lee stated an updated work order list will be done early 2020.

Lee stated 8 or 9 entry doors have been painted, not all residents would allow access. G. Ferguson will regenerate a new list for Geig to work on during the next 3 to 4 good weather days.

- **42)** Shrubbery, trees/limbs needed trimming that are close to or touching building walls, gutters or roofs: These issues will be determined at the time of the walk around.
