Prospectus for Glynn Visual Arts Exhibition

ANYTHING GOES

a non-juried exhibition

August 6 – September 7, 2018

Glynn Visual Arts is seeking entries for a non-juried art exhibition, August 6th – September 7th, 2018. In this show, the sky's the limit and anything goes! We are looking for the artists' favorite pieces - those that you are most proud of creating, or works that may not fit in our other themed shows. The possibilities are endless for this "anything goes" exhibition. There are no restrictions on content, style, medium or context. We invite and encourage ALL artists to participate. Works in any medium including, but not limited to Acrylic, Airbrush, Assemblage, Charcoal, Color Pencil, Collage, Digital Art, Drawings, Encaustic, Fiber Art, Graphite, Illustration, Mixed Media, New Media, Oil, Painting, Pastel, Photography, Watercolor, Pottery, Jewelry and Sculpture are all encouraged.

General Guidelines:

- Onetime \$35 entry fee is required for entry to this exhibition. Jury fee must be paid on-line or mailed to GVA before deadline for entrant to be eligible for exhibition.
- \$35 entry fee is waived for all GVA Members at the \$100 Artist Level or above.
- Artwork must be appropriately mounted or framed and ready to hang. No saw-tooth hangers. This means you must have at least a 5" wire across the back of your piece in order to hang it on our Walker Hanging System. Gallery wrap canvases must be painted on the sides and must be 1.25" or more in depth. THIS REQUIREMENT WILL BE STRICTLY ENFORCED.
- Artwork must be wholly original and created by the presenting artist. Works must not infringe on any rights, copyrights, trademark rights, rights of publicity, or proprietary rights of any other individual or entity. Work must have been created within the last year.

Submission Guidelines: **NEW! Please read carefully!**

- Artists may submit up to three (3) pieces of art for the \$35 fee. (NOTE: Depending on space availability, at least one work per artist will be exhibited but not necessarily all three.)
- Artists shall deliver artwork to Glynn Visual Arts no later than August 4th, 2018

Conditions of Exhibit:

GVA requires a commission of 40% on all works sold. Payment to the artist/exhibitor for works sold, will be made by GVA, after a complete and accurate accounting, by the 20th of the following month. Every effort will be made to assure that the work exhibited is protected while in the custody of the GVA. However, the artist is responsible for all insurance on exhibited work.

Publication Waiver:

Entering artwork constitutes permission for GVA to use images and publish images of artwork as advertisement in print materials, the GVA website and other GVA social media outlets featuring the exhibition. Proper credit will be given to the artist in the event the artist’s images are used in any promotion materials.

- Artists may pick up artwork Saturday, September 8th, 2018 between 10:00am - 5:00pm.
All artwork must be picked up NO LATER than September 8th by 5:00 p.m. unless prior arrangements have been made. After September 8th the artwork becomes the property of Glynn Visual Arts.
