LOUISIANA SUMMER INSTITUTE FACT SHEET

Dates: Saturday, July 24 – Saturday, July 31, 2010

Location: Paul M. Hebert Law School (LSU Law School), 1 East Campus Drive, Baton Rouge, Louisiana. The East Campus Apartments are a three – four minute walk away from the Law School.

Lodging: East Campus Apartments on LSU Campus. The East Campus Apartments offer space and privacy with all the benefits of living on a college campus. They are conveniently located within a short walking distance of the LSU Law School. Apartments provide state of the art accommodations including basic cable TV, in room data connections, washer/dryer combinations, and full size kitchens with microwave ovens and garbage disposals. Each apartment has attractively furnished living room, bedrooms, and dining areas. Each apartment contains four private bedrooms and two baths. Bed linens, blankets and pillows will be furnished. This is campus life - bring with you everything you would bring with you if you were going to college or grad school for a week.

Directions to East Campus Apartments: Coming from either east or west on I-10 exit at Dalrymple, take a right. There will be a big curve. The first street after the curve is East Campus Drive. Take a left, go to first stop sign and take a left in to the East Campus Apartments parking lot. (Directions courtesy of LSU Parking Dept.)

Registration – East Campus Apartments from 3 – 5:00 p.m. on Saturday, July 24, 2010. **Go to the Nora Power Activity Building to pick up your packet and keys.**

Meals: The opening dinner and closing lunch will be held at the Faculty Club located directly next door to the Law School and a short walk from your apartment. The opening dinner will begin at 6 p.m. and the closing lunch will begin at 11:30 a.m.

From Sunday, July 25 through Thursday, July 29, breakfast, lunch and dinner is at the “5” cafeteria. This is LSU’s newest and finest cafeteria. The “5” is a 14 minute walk from the East Campus Apartments. It is a 10 minute walk from the steps of the Old Law School building. You will be furnished walking and driving directions to the “5”.

On Friday, July 30 the “5” is closed. Breakfast and lunch will be provided at the Law School. Dinner will be at the Side Porch at Mike Anderson’s Seafood Restaurant. On Saturday, July 31, breakfast will be held in the foyer of the Old Law School.

Complimentary Parking- East Campus Apartments Parking lot – parking passes will be furnished at registration. Your passes are good on campus at any green coded parking lot.

Mileage – Summer Institute attendees who travel over 100 miles round trip will be eligible for a scheduled mileage reimbursement.
