# ISO Integrated Management System TALA - 4 Days

## Program Overview

This course provides participants with an in-depth understanding, knowledge, and skills needed to carry out successful internal and external ISO IMS Audits. This course qualifies participants to be a Lead Auditor for ISO 9001, ISO 14001 and ISO 45001 as well as audit Integrated Management Systems. The program is 4 days with a prerequisite of successfully completing the IMS Practitioner Course, which qualified participants on the standards prior to the auditing course. During the audit course, the first two days cover the Auditor Fundamentals and Lead Auditor qualification requirements. On Day 3 and 4 participants apply all the knowledge by auditing a management system that incorporates quality, occupational health and safety and environmental under one Integrated Management System. The Executive Review & Accreditation Committee will review the audit report for qualification. Due to the competency requirements, this course is limited to 6 participants (1 Audit Team) per Instructor. Upon successful completion you will receive your Leather-Bound Credentials, IMS Lead Auditor Designation, Registered Professional Number (RPN); and 3.0 Accredited IACET CEUs. Throughout the audit, participants undergo observations and receive competency assessments by certified auditors and subject matter experts.

- Auditing preparation, performance, reporting, and follow-up


