Heluna Health on behalf of Saving Our Legacy, African American for Smoke Free Safe Places – The SOL Project will award up to three organizations who want to advance policy or system change and increase awareness on the issue of tobacco-related disparities or address social determinants of health in the African American community in the Gold Country Region (GCR) Counties of Alpine, Amador, Calaveras, El Dorado, Inyo, Mono, Nevada, Placer, Sacramento, San Joaquin, Stanislaus, Sutter, Tuolumne and Yolo). This round of funding is open to African American youth-focused organizations based in the cities of Elk Grove Rocklin, Roseville, Tracy, Modesto, Turlock, Sonora or Yuba.

### Introduction and Background:

The SOL Project was established in 2007 to adopt tobacco control policies and to address social determinants of health that impact African American (AA) communities. Staff of the SOL Project has worked in the Gold Country Region (GCR) for 20 years under the auspices of the African American Tobacco Education Network/Partnership, the Gold Country Tobacco Control Coalition and the County of Sacramento Tobacco Education Program. SOL Project staff are experts in working with the AA population in the areas of tobacco control, prevention and advocacy.

The GCR consists of 14 counties with urban and rural communities in northern/sierra, Sacramento Area and San Joaquin Valley, including 48 incorporated cities. The total population is 3.83 million people, with just under 1,200 people in Alpine County, to over 1.4 million people in Sacramento County. The GCR is ethnically diverse with 51.1% White, 27.2% Latino, 10.9% Asian, 5.4% Black/African American and 4.1% are two or more races. There are 297,000 youth ages 12-17 and approximately 9.1 % are African American.<sup>i</sup>

Ninety percent of adult smokers begin while in their teens, or earlier; and two-thirds become regular, daily smokers before they reach the age of 19.<sup>ii</sup> Therefore, youth have an important role in advocating for policy and systems change in tobacco control and social determinants that impact the health of their communities and future. Youth have credibility with peers and community members. This allows them to help educate the community to reduce pro-tobacco influences and increase healthier norms and behaviors. Youth can provide important insight about their generation. Involving youth in tobacco control efforts ensures the design of effective, population-specific policies. Youth can mobilize their peers for activities and facilitate access to many arenas. These actions add strength to tobacco control policy efforts while also broadening the type and number of venues involved in message delivery.<sup>iii</sup>

Smoking is a major contributing factor leading to premature death of African Americans (AA). AA experience the highest lung cancer incidence and mortality rates of all other racial and ethnic groups in California. [ii] The higher rates may result, in part, from AA smokers being much more likely to smoke menthol cigarettes than Whites.<sup>iv</sup> Overall, more than 88 percent of AA smokers (ages 12+) smoke menthol cigarettes, compared to 26 percent of White smokers. Rates of menthol use are highest among AA smokers ages 12-17 (95%) and 18-25 (94%). The popularity of menthol is also evident in the cigarette brand preferences of AA youth who smoke. More than 73 percent of AA youth ages 12-17 prefer Newport.[iv] Menthol is a candy flavoring that masks the harshness of tobacco smoke and serves as starter products for kids (*It helps the poison go down easier*)—Phillip Gardiner, Dr. P. H., Policy and Regulatory Sciences, Program Officer, Tobacco Related Disease Research Program.

Legalization of marijuana poses a new threat for secondhand smoke exposure. Secondhand marijuana smoke contains many of the same chemicals and carcinogens as secondhand tobacco smoke. Secondhand marijuana smoke contains more than twice as much tar and ammonia as tobacco smoke, and more than eight times as much hydrogen cyanide.<sup>v</sup>

Marijuana use among African Americans (AA) adults increased in the U.S. from 4.7% in 2001-2002 to 12% in 2012-2013.<sup>vi</sup> Prevalence of current marijuana use among high school students who were current cigarette or cigar users increased from 51.2% in 1997 to 62.4% in 2013, while the prevalence dramatically increased among AA (66.4% to 82.0%) students from 2009-2013.<sup>vii</sup>

With the legalization of marijuana and dual use with tobacco, there is need to update voluntary and legislative tobacco control policies to include this and other “smoked” products that emit air pollutants.

The goal of this funding opportunity is to strengthen the capacity of youth serving nonprofit organizations serving African American communities and engage youth in the fight against tobacco industry targeting in the Gold Country Region.

### Organization

The SOL Project operates under the fiscal sponsorship of Heluna Health. Heluna Health is a leading provider of program and support services across the population health spectrum, empowering academic researchers, public-private consortia, public health agencies, and nonprofits to achieve positive health outcomes.

This funding opportunity is open to African American- youth led nonprofit organizations or projects with a tax-exempt non-profit organization status under Section 501(c)(3) of the Internal Revenue Code and are designated a 509(a)(1) or 509(a)(2) organization.

An African American-led organization is defined as one:

- that has an explicit mission to serve African American populations; and
- key executive staff with policy and decision-making authority, and at least half of its board of directors, represent the African American population.

Additional eligibility criteria for the 2019 funding round:

- The application must include addressing tobacco use or tobacco-related diseases; or other natural plant or synthetic based products use; or electronic smoking device use (which includes vape or JUUL devises); and the related health disparities as a result of the use of these products.



### Geography

Applicant organizations must serve residents living in at least one of the Gold Country Region (GCR) cities of the SOL Project’s funded area. These cities are Rocklin, Roseville, Tracy, Modesto, Turlock, Sonora or Yuba.

## Selection Criteria

The most competitive applications will:

- Make the case of how your organization will engage African American youth in tobacco control efforts such as advancing policy or systems change (E.g., changing the definition of smoking to include other plant and synthetic products in a current policy); or increase awareness about tobacco or tobacco related products (E.g. educating community about how the tobacco industry targets this population with products like flavored little cigars, blunt wrappers and electronic smoking devices); or increase awareness about social determinants of health as it related to tobacco, vape and/or JUUL products (E.g., educating the community on where a person lives impacts their health like living in food deserts, living near toxic waste, etc.);
- Indicate that the applicant organization has been established for at least one year;
- Include a reasonable scope and budget, based on this funding opportunity's parameters.

## Funding Information

- **The maximum award amount per organization: up to \$4,900**
- The term must end by [April 30, 2020](#).
- Only one proposal per organization will be considered.
- Those receiving awards will be expected to participate in trainings, monthly conference calls or webinars.
- Travel costs to attend the training and any other activities in the scope of work is the responsibility of the funded organization and may be included in the proposed budget (up to \$500).
- Those receiving awards will be required to submit a final progress report due [April 30, 2020](#).

Funds may be disbursed in two increments: upon execution of agreement and upon successful completion and approval of final report submission due [April 30, 2020](#). Funds will not be disbursed until all documents are on file and agreement is executed.

*(Note: SOL Project will provide successful applicants with a template to submit the final report. If the final report is not submitted, submitted late or submitted without completion of activities; it is the discretion of SOL Project/Heluna Health to deny final award disbursement of funds. Furthermore, the organization will not be eligible to apply for funding in the future).*

- Examples of what funds may be used for (proposals are not limited to these examples):
  - Operating expenses
  - Social media campaigns
  - Awards in excess of \$3500 may include staffing, consultants, stipends (not exceeding more than 50% of total award)
  - Meeting space, food – not to exceed \$50 per person, per contract year.
  - Travel - up to \$500

## What We Do Not Fund
