AN ORDINANCE

Adopting and Amending ordinance No. 2018-64 (Permanent 2019 Appropriations) by appropriating from unappropriated funds and transferring appropriations in the General Fund and Sewer Fund and declaring an emergency.

- BE IT ORDAINED by the Council of the City of Fostoria, Seneca, Hancock, and Wood Counties, Ohio:
- <u>SECTION 1:</u> That ordinance No. 2018-64 (Permanent 2019 Appropriations) passed December 18, 2018, be, and the same is hereby amended as delineated in the following sections:
- <u>SECTION 2:</u> That Two Thousand One Hundred Dollars (\$2,100) be appropriated from unappropriated funds to 101-100-531240 General Fund/Security of Persons and Property-Police/Contractual Services-Lease Payment.
- <u>SECTION 3:</u> That Eight Hundred Dollars (\$800) be appropriated from unappropriated funds to 101-400-531240 General Fund/Community Environment-Zoning/Contractual Services-Lease Payment.
- <u>SECTION 4:</u> That Three Hundred Dollars (\$300) be appropriated from unappropriated funds to 101-400-541270 General Fund/Community Environment-Zoning/Materials and Supplies-Fuel.
- <u>SECTION 5:</u> That Seven Thousand Five Hundred Dollars (\$7,500) be appropriated from unappropriated funds to 101-660-531700 General Fund/Transportation-Airport/Contractual Service-Other Contractual Services.
- <u>SECTION 6:</u> That One Thousand Dollars (\$1,000) be appropriated from unappropriated funds to 501-510-531510 Water Fund/Basic Utility-WTP/Contractual Service-Gas.
- <u>SECTION 8.</u> That Five Thousand Five Hundred Dollars (\$5,500) be transferred from funds appropriated in 101-740-541999 General Fund/General Government-Auditor/Materials and Supplies-Repairs and Maintenance to 101-740-531700 General Fund/General Government-Auditor/Contractual Services-Other Contractual Services.
- <u>SECTION 9.</u> That Four Thousand Dollars (\$4,000) be transferred from funds appropriated in 101-740-541999 General Fund/General Government-Auditor/Materials and Supplies-Repairs and Maintenance to 101-740-559001 General Fund/General Government-Auditor/Capital Outlay-Furniture/Equipment.

<u>SECTION 10.</u> That One Thousand Five Hundred Dollars (\$1,500) be transferred from funds appropriated in 101-741-541999 General Fund/General Government-Income Tax/Materials and Supplies-Repairs and Maintenance to 101-741-531700 General Fund/General Government-Income Tax/Contractual Services-Other Contractual Services.

<u>SECTION 9.</u> That One Thousand Five Hundred Dollars (\$1,500) be transferred from funds appropriated in 101-741-541999 General Fund/General Government-Income Tax/Materials and Supplies-Repairs and Maintenance to 101-741-559001 General Fund/General Government-Income Tax/Capital Outlay-Furniture/Equipment.

<u>SECTION 10.</u> That Fifty Thousand Dollars (\$50,000) be transferred from funds appropriated in 520-520-500110 Sewer Fund/Basic Utility-WWTP/Personal Services-Full Time Services to 520-520-531185 Sewer Fund/Basic Utility-WWTP/Contractual Services-Outside Laboratory Testing.

SECTION 11: That this ordinance shall be published in accordance with applicable Ohio Law.

SECTION 12: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal actions were in meetings open to the public, and in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

<u>SECTION 13:</u> That in order to preserve the public peace, health, safety and welfare of the City of Fostoria and its inhabitants, and in order to make the appropriation adjustments in the Permanent 2019 appropriations without delay to meet pending obligations, this measure is determined to be an emergency ordinance and shall take effect at the earliest time allowed by law after its passage.

THEREFORE, upon the affirmative vote of two-thirds (2/3) of all members elected to Council, and signature by Mayor, this ordinance shall take immediate force and effect.
