City Council Minutes

December 2nd, 2019

The City Council of the City of New Munich met in regular session at 6:30p.m., in the City Hall. Jim Poepping, Shawn Duevel, Pat Nathe, Ron Doll were present and Elmer Boecker was absent.

On a motion by Ron Doll, seconded by Shawn Duevel and carried the minutes from November 4th, 2019 were approved.

Fire Chief, Allen Fiedler was present to inform the Council of one medical call last month. He mentioned #1 Fire Truck Engine was having some issues, the pump test did not pass and also issues with the transmission and radiator. They are looking into cost to repair or another option would be to purchase a truck replacement from a local town. More information will be presented at the next council meeting. Al had one bill for IamResponding for \$305.00.

Waste/Water Operator, Tom Valerius was present to inform the Council that the ponds are going well; no issues and they are ready for winter. Tom and Jim met with an engineering company to take a look at the water tower liner for another quote. We were told that MN Dept of Health needs to sign off on whatever plan we decide. We are going to get a few more quotes since it is a very expensive repair/project.
