Minutes of February 7, 2022

The Huntington Township Trustees met in regular scheduled session at 7:00 PM at the Township Hall. Meeting called to order with the pledge of Allegiance by Walter Rollin. Also present were Robert Holmes, Matt Combs, Jed Lamb, Dimitri Szynal, Carl Strekely, Doug Rief and Sheila Lanning. *Motion* by Holmes with a second by Lamb to approve the minutes of January 17, 2022 as written. Roll call: three yeas. *Motion* by Holmes with a second by Lamb to approve the January 2022 financial reports with year to date revenue of \$19,594.40, expenditures of \$9,688.57 and bank balances of \$409,571.91. Roll call: three yeas. Discussion on *Resolution 2022-32* pertaining to the use of American Rescue Funds. Trustees tabled passing the Resolution until further review. Checks 9818-9840 and payments totaling \$12,802.15 were authorized for payment.

Chairman Rollin opened the bid received for hauling of stone. D & J Rief Services was the only bid received. Discussion on the bid, all required documents received, *Motion* by Lamb with a second by Rollin to award the stone hauling bid to D & J Rief Services. Roll call: three yeas.

COMMITTEE REPORTS:

WATER- Lamb: meeting Wednesday

LORCO- Lamb: meeting Thursday but may not make the meeting.

AMBULANCE- Holmes: Advertising for a new Director, resumes should be submitted by February 28th.

FIRE- Rollin: Still looking for pickup truck, holding out for Government bids. Fireman's banquet had a good program, not held for 2 years due to COVID.

ZONING- *Motion* by Lamb with a second by Holmes to appoint Matt Combs as Zoning Inspector at a pay of \$400.00 a month retroactive to February 1st 2022. Roll call: three yeas. Combs: attended Zoning training at the Ohio Township Association Conference. *Motion* by Lamb with a second by Holmes to appoint Carl Strekely to the Zoning Board of Appeals for a term of 1/1/2022-12/31/2026. Roll call: three yeas. Lanning: email asking for FOIA information on Rochester Manufacturing sent to Tom Mangan. Talked to Fire District Assistant Chief Bill Brown about a new address for house being constructed on West Road. Mr. Brown stated that in the past, Dennis Finkel and he would discuss new home numbers based upon frontage and surrounding homes.

OFFICE ON AGING- Lanning: received healthy living grant application, *Consensus* to apply for the electrification of the Park pavilion with the 2022 grant.

CEMETERY- Rollin: Prosecutor Tom Mangan mailed 1951 deed to the Cemetery West land and copies of ORC related to cemeteries. Lanning: full burial of Nancy Priddy on 1/28/2022, full burial of Richard Chester on 2/1/2022. Busch Funeral Homes call Lyn Ickes on Dennis Finkel's phone, informed them of the proper phone number to call the Sexton 440-647-0040.

ROADS and EQUIPMENT: Lanning: received letter from Engineer on annual County chip and seal program. *Consensus* to not apply for annual chip and seal program through the County Engineer. Combs: weather did a job on the roads, replaced bearings on spreader. Lamb: Stewart Road culvert property owners willing to help in any way.

RECYCLING- Lanning: 2021 statistics= 83.40 tons recycled and entered into ReTrac system. Received credit of \$13.50 from Rumpke on the missed dumpster pick up. Holmes: probably could use another

recycle bin, will call Rumpke and order one. Rumpke cost going up \$.43 due to fuel costs. Carl Strekely: a guy was using a shovel to move recyclables to the back of the recycling bin.

PREVIOUS BUSINESS:

Holmes gave list of Dennis Finkel's tools to Lamb to affix a fair cost for the Township to pay. New / renovated garage cost estimate of \$450,000.00 given to the Lorain County Commissioners. Discussion by Trustees at a work session covered options of a new garage using the property that is currently the small ballfield behind the Township Hall. Lanning: Farm and Home added Combs as an authorized purchaser to the Township account. The mileage for 2022 is \$.585 cents per mile. Attended the NOACA webinar on the federal infrastructure act, largest investment in bridges since 1950's expected with the funds and new grants will include "Rural Surface Transportation" and "National Culvert Removal, Replacement and Restoration" totaling 1 billion.

NEW BUSINESS:

Lanning: Lorain County Auditor Snodgrass presentation at LCTA meeting on triennial property value update showed estimates that the Township may get an additional \$24,848.00. Completed: Federal W3, Ohio IT3, 941, 1099 NEC, OPERS noncontributing, annual financial reports, 1095 B. UAN costs may increase based upon the annual financial report filed for 2021. Received OTARMA capital distribution \$849.36 but not the MORE grant. *Motion* by Lamb with a second by Holmes to authorize the purchase of overalls from KET for employees and file for reimbursement through the MORE 2022 safety grant. Roll call: three yeas. *Consensus* to authorize the purchase of safety boots for the employees and to file for reimbursement through the 2022 MORE safety grant. Roll call: three yeas. Lanning: Local Government Conference is virtual and free on 4/13 & 4/14. Holmes: the April Lorain County Township Association meeting will be in Huntington, requesting a quote from Frances Rollin for food.
