Airbnb? VRBO?

As part of the new sharing economy, lodging services also known as short-term rentals in private residences, have seen a rapid expansion. At websites such as Airbnb, VRBO, and Homeaway, homeowners can list a room or house for rent for just a few days or several weeks. If you have considered listing your home on any of these websites, please stop now. Article 2, Section 1 of the covenants of Andover Glen restricts the use of homes in our association to residential purposes only.

The City of Aurora recently finalized regulations on these types of services. They stipulate that the regulations do not override HOA covenants that prevent homeowners from engaging in this type of activity. SHOVEL THOSE WALKS!

Fortunately, we have had a mild winter so far, but there are still several months left in the snow season. It seems that the board receives several complaints about un-shoveled sidewalks each time we have a snowstorm. This is not a covenant issue, but a city code violation issue. Violations can be reported to the city at 303-739-7000. Fines and fees can reach up to \$50 and a possible court appearance. Ask a neighbor or hire a contractor to clear your walks if you are away, or unable to perform the task yourself. Be a good neighbor and keep your walks cleared of snow and ice for the safety of all.

PROPERTY IMPROVEMENTS

The days are getting longer and the annual Home & Garden Show is just weeks away. Many residents are making plans to upgrade their property this year. This is a reminder that Andover Glen residents are required by HOA covenants to have any property improvement such as roof replacement, house painting, new windows or gutters, new landscaping, etc. approved by the HOA Architectural Basically, if the Control Committee. change or improvement can be seen from the street, it requires an approval at least two weeks prior to the start of work. Architectural Change Request forms are available on the Andover Glen website: www.andoverglen.org. Also, for your added convenience, a form is included with this month's Gazette. Once the forms are completed, they need to be Bill Schwab (committee given to chairman) or to any HOA Board member. Make sure to submit an Architectural Change Request form for any visible changes you make to your property to avoid any unnecessary delays in your project.
