

AMELIA VILLAGE, OHIO
Ordinance O-2014-51

AN ORDINANCE CREATING THE POSITION OF ASSISTANT FISCAL OFFICER AND APPOINTING JOEL M. GILPIN TO THE POSITION AND DECLARING AN EMERGENCY.

WHEREAS, pursuant to Ohio Revised Code §733.262, Village Council previously enacted Ordinance O-2009-26 to combine the duties of the Village Clerk and the Village Treasurer into one appointed position known as the Village Fiscal Officer; and

WHEREAS, in Ordinance No. O-2014-07, the Amelia Village Council appointed William R. Gilpin to the position of Village Fiscal Officer; and

WHEREAS, Mr. William Gilpin has had to reduce his hours in the position of Village Fiscal Officer; and

WHEREAS, the Mayor has recommended that the Village Council appoint Mr. Joel M. Gilpin to the position of Assistant Village Fiscal Officer to assist the Fiscal Officer with the duties of the office of Fiscal Officer.

NOW, THEREFORE, be it ordained by Council of Amelia Village, Clermont County, Ohio that:

SECTION I. Due to the reduction of hours by the Village Fiscal Officer, this Council hereby creates the position of Assistant Fiscal Officer to assist the Fiscal Officer with the duties of the office of Fiscal Officer.

SECTION II. Mr. Joel M. Gilpin is hereby appointed by the Mayor and approved by a majority of the Council of Amelia Village as Assistant Village Fiscal Officer.

SECTION III. Mr. Joel M. Gilpin is appointed to the position of Assistant Village Fiscal Officer at the annual salary of Fifteen Thousand Six Hundred Dollars (\$15,600.00).

SECTION IV. Mr. Joel M. Gilpin is not required to live within the municipal boundary of Amelia Village.

SECTION V. Village Council hereby finds and determines that all formal actions relative to the passage of this Ordinance were taken in an open meeting of this Council, and that all deliberations of this Council and of its committees, if any, which resulted in formal action, were taken in meetings open to the public, in full compliance with applicable legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION VI. This Ordinance is declared to be an emergency measure necessary for the immediate preservation of the public health, safety and general welfare of Amelia Village and its inhabitants. The reason for the emergency is the immediate need to appoint an Assistant Fiscal Officer to ensure the financial stability and security of Amelia Village. Therefore, provided this emergency clause receives the affirmative vote of two-thirds of all members of Council it shall take effect and be in force immediately upon its passage and approval by the Mayor, otherwise from and after the earliest period allowed by law.

DC moved to suspend the rules requiring three readings on three separate dates.


