State Chaplain—Fr. Franklin Miller



"Glory to God in the highest heaven, and on earth peace among those whom he favors" (Lk 2:14)! A multitude of angels sang the praises of God to the shep-

herds in the fields. They were "living in the fields and watching over their flocks" (Lk 2:8b) as shepherds had done for centuries. However, in this one night the world would be changed forever. The God-man would be born in a humble stable in Bethlehem as the child of Mary and Joseph. He came to establish a kingdom in the hearts of those who are willing to believe in him and to accept him as savior. However, "to become a child" in relation to God is the condition for entering the kingdom. For this, we must humble ourselves and become little. Even more: to become 'children of God' we must be 'born from above' or 'born of God'. Only when Christ is formed in us will the mystery of Christmas be fulfilled in us. Christmas is the mystery of this 'marvelous exchange': 'O marvelous exchange! Man's Creator has become man, born of the Virgin. We have been made sharers in the divinity of Christ who humbled himself to share our humanity" (Catholic Catechism of the Catholic Church, 526). Our hearts and minds become transformed as we allow the Lord Jesus to lead us from a life of sin to a life of grace.

"Grace is a participation in the life of God. It introduces us into the intimacy of Trinitarian life ..." (CCC, 1997). It is an invitation of life and love. A love expressed to us by the Incarnation, "and the Word became flesh and lived among us, and we have seen his glory, the glory as of a father's only son, full of grace and truth" (Jn 1:14). The kingdom of truth and grace is entered into in a great and mysterious way by our acceptance of the new born king. Blessed John Paul II wrote in Lav Members of Christ's Faithful People. (Christifideles Laici) "because the lay faithful belong to Christ, Lord and King of the Universe, they share in his kingly mission and are called by him to spread that Kingdom in history. They exercise their kingship as Christians, above all in the spiritual combat in which they seek to overcome in themselves the kingdom of sin (cf. Rom 6:12), and then to make a gift of themselves so as to serve, in justice and in charity, Jesus who is himself present in all his brothers and sisters, above all in the very least (cf. Mt 25:40).

State Project—Project Ignite Light

In the midst of this giving season, I would like to share with you some details about our State Project that the North Dakota Catholic Daughters are supporting over the next two years. Those of you who attended the state convention may recall voting to support "Project Night Light."

This summer the group had a bit of a transition and is now known as "Project Ignite Light" (PIL). Project Ignite Light is a ND based organization through which children are provided important items needed when they



are examined by their local advocacy center or hospital for physical abuse, sexual abuse, or neglect.

In 2008, over 4000 children were seen around the state

of North Dakota for abuse or neglect. It is the goal of Project Ignite Light to equip each child that enters a hospital or advocacy center to be seen for these reasons with a "Bag of Hope." Each "Bag of Hope" includes: Fleece tie blanket, pajamas, socks, underwear, shampoo, conditioner, toothbrush, toothpaste, water bottle, flashlight, and a book, "You are Special" by Max Lucado. Often children in these situations are left feeling insecure and unsure of themselves and the people around them. Through Project Ignite Light, they receive a small piece of security. Because so many of the hurting children feel used, only new items are placed in the bags.

Project Ignite Light moved their headquarters to a new location this summer. Pebbles Thompson and her family now live and run the non-profit on a

Bus Information for 2014 National CDA Convention

The Dakota Trailways chartered bus company has been contacted about the possibility of taking a chartered bus to the 55th Biennial National CDA Convention in Billings, Montana. The convention dates are July 16-19.

The dates, times and places for pick-up of CDA members across North Dakota have been set. The date of departure for the convention if you ride the bus would be Sunday, July 13.

The first place to board would be in Fargo at the Petro Serve USA Truck Stop at 8:00 a.m. CDT. The next stop is scheduled for Stamart at 12:30 p.m. CDT in Bismarck. The last stop scheduled is the Law Enforcement Center in Dickinson at 2:00 p.m. MDT. Additional stops at Valley City or other places along I94 could be scheduled if requested.

The bus would leave on July 20 from Billings for the return trip home.

The cost for the chartered bus ride is \$200 per person which must be prepaid by February 15. No refunds will be given. Forty passengers are necessary to be able to charter the bus.
