Zoning Officer Report: Zoning report reviewed. Mr. Elhage has his permits to change his barn into a residence. ZBA will meet to discuss an area variance.

Highway Superintendent Report:

CHIPS was discussed with the Highway Superintendents, as well as Snow and Ice contracts. (Supervisor May thanked Mr. Roggow for attending.) Mr. Roggow thanked the Board for allowing him to attend the education. Cleaning up the plows and equipment. Have an engineer to sign off on Buffalo Hill, maybe in August. Getting an extension on the permit on Royce Road, the culvert collapsed. Matt's truck needs new lines for the box, \$3,500, maybe a little less, there is a seal pump issue. Working on patching and started mowing. Oil and stone cost is going up to \$400/mile. We have been doing driveways for residents. New 1- wheeler came in, will be ready maybe be by September 1st. There was discussion regarding shinny blacktop of binder and sealer.

Supervisor May opened the Public Hearing on Land subdivision and separation. There were no questions from the audience. Ms. May read a card of thanks from Wyomco.

Town Clerk Report: Our Town website visits for May 2129. The Towns total revenue for the month of May 2019 was \$781.00, \$306.00 for dog licenses, \$15.00 for late fees, registrar - \$120.00, \$235.00 for Zoning, DEC - \$25.00 and Marriage License - \$80.00. We had 22 renewal license and 1 new license. To the general fund, Supervisor May \$511.38, Dogs were \$105.00, \$15.00 in late dog license fees, \$235.00 for Zoning, DEC- \$1.38. Registrar-\$120.00 and marriage \$35.00. We disbursed \$160.00 to Wyoming County, \$41.00 to Ag and Markets for dogs, DEC-\$23.62 and NYSDOH-\$45.00.

Supervisor May requested a motion to approve the 2019 General Funds bills: Abstract #6 Vouchers #86 to #105, totaling \$28,901.95. A motion was made by Mr. Herman, seconded by Mr. Flint to approve the payment of the General Fund bills. Ayes [4] May Boxler Flint Herman Ahl. Noes [0] Carried

Supervisor May requested a motion to approve the 2019 Cemetery Fund bills: Abstract #1 Vouchers #1 to #6, totaling \$1935.00. A motion was made by Mr. Flint, seconded by Mr. Ahl to approve the payment of the Cemetery Fund bills. Ayes [4] May Boxler Flint Herman Ahl. Noes [0] Carried
