- 4) Officer Reports
 - PRESIDENT Jen Berry

- Education Richard Snedegar Chapter 5 has 7 new classes scheduled for 2017 and possibly
 one more class if it gets approved in time. Course 502 will take place in Topeka between course

1 and 2 on April 13th. Electric Transmission class (218) only has three instructors in the nation and we can add to the fall schedule if needed, maybe in October/November. We received a call from Southern Star Energy and they have four people interested in taking Course 100. Course 100 is needed for RWA so we should consider the class. Need to ask Al Donoho before scheduling since he would be the teacher in the local region. Future class offerings will need to be adjusted based on new certification requirements.
