MINUTES FOR VILLAGE OF CODY PUBLIC HEARING FOR THE 1 & 6 YEAR STREET PLAN and REGULAR MEETING FEBRUARY 13, 2018 AT 6:30 PM AT ACC

A motion was made by Williams and seconded by Jones to approve the CNEDD Interlocal Agreement. After discussion all voted in favor, motion passed. A motion was made by Jones and seconded by Williams to approve the CNEDD Resolution. After discussion all voted in favor, motion passed. A motion was made seconded by Fish to have Michael Knapp as the alternate representative to the CNEDD. After discussion all voted in favor, motion passed.

New Business: A motion was made by Jones and seconded by Knapp to table approval of street plan resolution until next month. NVC will update the plan. After discussion all voted in favor, motion passed. Randy Schneider addressed the board with a request to approve a subdivision of a portion of a lot that was purchased by Randy & Lisa Schneider. After discussion, Jones made a motion seconded by Knapp, to approve the following resolution: BE IT RESOLVED BY the chairman and the board of trustees of the Village of Cody, Nebraska, that the subdivision of Lot 14, Block One, Vogt's Addition to the Village of Cody as shown in Deed Book 101 at page 301 showing Randy Schneider and Lisa Schneider, husband and wife, as grantees, be and the same is hereby approved. All voted in favor, motion passed.

Maintenance Report: New rims and tires for the trash truck will be \$4800.00. This issue will be added to the agenda next month.
