## **Nebraska Violent Encounter Survival Training**

**Session Description:** Information regarding line-of-duty assaults and deaths of law enforcement officers has been extensively collected since 1960. Data has shown an increase in ambushes on our nation's law enforcement officers. This training session will provide relevant, high quality, potentially lifesaving information to law enforcement agencies focusing on why an incident occurred as opposed to what occurred during the incident, with the hope of preventing future incidents.

ABOUT THE SPEAKER: William D Baker is the Chief of Police in Foxborough, Massachusetts. Chief Baker started his police career in 1974 in Cumberland, Maine. Chief Baker has served in law enforcement for over 45 years. In addition to his municipal experience, Chief Baker has also served in Massachusetts as the Director of Police Training and Assistant Secretary of Public Safety. He was worked for the Department of Justice as the acting program manager for Haiti. In addition to the law enforcement experience, Chief Baker spent four years as the Assistant City Manager of Westbrook, Mass. and as a consultant for BerryDunn.

## 2017 Las Vegas Mandalay Bay Mass Casualty Incident

**Session Description:** The area of the shooting covered 990 square miles, where over 22,000 people attended the Route 91 Harvest music festival that night. Between 10:05 p.m. and 10:15 p.m., 64-year-old Stephen Paddock fired more than 1,100 rounds from his suite on the 32nd floor of the Mandalay Bay Hotel. The incident would come to be known as the deadliest mass shooting committed by an individual in the United States, claiming the lives of 58 people and leaving 851 others injured from gunfire and the resulting panic. The session highlights key learning objectives from both a tactical, investigative and strategic perspective.

**ABOUT THE SPEAKER:** Sergeant Jerry A McDonald (ret) spent over 25 years with the Las Vegas Metro Police Department, recently retiring in February 2019. Sergeant McDonald served in numerous roles in his career, including time as a supervising detective in the Force Investigation Unit that investigated the 2017 Mandalay Bay mass casualty shooting.

#### 2018-19 Legal Update

**Session Description:** Assistant Nebraska Attorney General Corey O'Brien will provide an overview of legislative and case law items of interest resulting from Nebraska Unicameral activity in 2018 and items of note in the current 2019 Unicameral session. Additionally, recent court cases that impact law enforcement will also be discussed.

**ABOUT THE SPEAKER:** Corey O'Brien is an Assistant Attorney General and the Criminal Bureau Chief for the Office of the Nebraska Attorney General. A graduate of Creighton University School of Law, Corey has been with the Attorney General's Office since 2003 assisting law enforcement and county attorneys in complex prosecutions, including homicide, sexual assault, robbery, public corruption, narcotics, firearms and child exploitation. Since 2013, Corey has been cross-designated as a Special Assistant United States Attorney in the areas of child exploitation, narcotics and firearms.
