NEW SYSTEM FOR CTTA IDENTIFICATION

We will not be using bracelets for beach identification this year. There will be a new ID badge system with PHOTO ID put in place. Each home (2 per family free of charge) will need to come to get their photo taken on one of the dates listed below. If additional badges are needed for other members of the home there will be a cost of \$15.00 per ID.

Proof of residency will be expected at the time of your picture being taken. This is mandatory for the implementation of our new ID system. The association is asking that members bring two forms of ID (one needs to be photo ID).

 Saturday April 25th rain date Sunday April 26th
 From 9:00am -12:00pm
 Sunday May 17th @ 2:00pm

- YOU NEED to provide proof of your insurance and registration.
- PLEASE MAIL ALL INFORMATION TO:
 - CTTA P.O. Box 166
 - BROOKFIELD, CT 06804
- You must have a minimum \$300,000 liability policy on any boat docked in our slips. Shown on your insurance policy.
- All boater must provide proof that CTTA is added as an additional insured on your policy.
- ALL DOCUMENTS NEED TO BE MAILED TO THE DOCK MASTER PRIOR TO MAY 15th.
- IF THESE ITEMS ARE NOT IN, WE WILL ASSUME THAT YOU are RELINQUISHING YOUR BOAT SLIP AND THE NEXT PERSON ON THE WAITING LIST WILL BE CONTACTED.
