NEW BOARD

David Bretzke reported that the legislature had changed the method of having the County Treasurer collect the taxs as in the past. He stated that after the County Commissioners discussed the matter with the City of Moab, the Grand County School District and the Grand County Water Conservancy District, decided the method of computation would be the same. We will continue to be billed for the Assessor and Treasurer's cost of collecting he taxes.

Dale reported he had drawn up a floor plan and met with JR.Nordfelt, the County Inspector. He and Dan had talked to Bailey at Custom Craft about carpeting for the place. Dale asked if we should piece meal the operation or have a single contractor do the work. He stated that when he has the specs put together, he would invite several bids from interested contractors, have an inspection day for everyone to examine the site. Gary moved to go ahead and advertise the invitation to bid, setting a date for the inspection. James Walker seconded. MOTION CARRIED. George stated we should decide on type of heat, and Dale said he would consult with Nelson's about what would be necessary to heat this building.

NEW OFFICE BUILDING

Dale reported there was an irrigation line leak, and he would plan to shut down the line this weekend and repair that line and install the master meter.

IRRIGATION LINE

James Walker reported he had talked with Mr. Burke Taylor, and the Cemetery District is planning to hook onto City water. They plan to use the well only for back-up. The Cemetery lines were discussed, and it was stated the line crossed the ditches three different places for delivery to

Moab Irrigation. D. L. stated we should draw up a potential DROUGHT CONagreement with well owners for use of their wells in a drought situation. Dutch was asked what was necessary find out about the development of the water at the cemetery, and he stated it just needed to be tested. Dutch stated he could do an eight hour test, costing about \$400.00. stated the 100 gallon per minute test would be adequate.

TINGENCY PLAN

Dale reported he had been out in the field with representatives of J. J. Johnson & Associates , and there is possibility there will be more water needed at the He stated that he had gone out with Sharon Myron, and set out some neutron probes in George and Gary's fields. They will do more probes, and then will coordinate their readings with the Datapod, and can find more about application rate necessary for proper irrigation.

Zimmerman asked if the county could buy the District's trailers presently stored at the County Yardfor the use of the Food Bank. George White moved the District turn them over to the County for the cost and moving. Walker seconded. MOTION CARRIED.
